1. Mr O'Halloran: Indeed. So it is not necessarily showing that there is fundamentally a drop in funding. What it is demonstrating is that, as we are going through and cleansing our data, and as you are aware, we have been doing a great deal of work in the last few years on actually cleaning our data, that is ensuring that we are much more accurate in what we are reporting and how the costs are apportioned across the system.

Secondly, as I said before and the minister has said, there has been significant work in the health services—Canberra Health Services and Calvary—in being more efficient in what they do. And so that is actually enabling them to deliver more services.

**MRS JONES:** So can I just maybe ask, on notice, for which items have therefore been removed from the data in that cleansing process, line by line? Can you provide that on notice?

Mr O'Halloran: We can provide that information on notice, yes.

2. Ms Stephen-Smith: Well, this is part of the reason that are actually currently looking at those issues around health funding, sustainability, and whether we are going to continue this approach going forward or whether we are going to take a slightly different approach or whether we, you know, simply—we will retain the envelope approach, but we will, know you, change the envelope. We really are still working through those positions.

**MRS JONES**: So can I just maybe ask on notice if the department can work out or if your office can work out when that decision was taken historically to go to that envelope approach where we look at the overall growth of the bucket rather than that specific projection per service, let us say, for the growth of the population?

- leave is taken and used within appropriate timeframes
- the Medical officer rostering office will actively monitor the rosters and flag staff who are consistently working more than 100 hours per fortnight.
- Junior Medical Officers in their first and second year of post graduate training do not work more than three on-call shifts per fortnight; and
- there is clarity on overtime expectations during orientation.

As part of this monitoring and assurance, JMO overtime trends are reported to the Executive Director of Medical Services, highlighting any instance where a JMO's timesheet exceeds 100 hours per fortnight, or includes more than three on-call shifts per fortnight, so that issues can be addressed with the responsible Clinical Director in the unit where the overtime occurred.

**Ms Chambers:** The way the funding comes through, is actually through our state pool accounts, through the National Health Reform Agreement.

For New South Wales actual breakup of that quantum, of the \$200,000, I could take that on notice, to get the actual specific. I did not bring my annual report booklet up with me. But there is actually a good blurb in the financial reporting section about what our cross-border revenue is. And also we have cross-border expenses of course.

And the way it is actually measured is on an annual basis we calculate, through the National Health Funding body reconciliations about how many interstate patients we have treated. And also how many ACT residents have been treated interstate.

**MRS JONES:** And how many staff are engaged in the business of managing, collecting, the data on how many people we have served? What is—let us say, which things they have had done to them in our system? And then how much therefore, you know. So is it like a 10-person team? Or, you know, can you take that—maybe you have to take that on notice.

**Ms Jonasson**: We would probably have to take that one on notice, I think, Mrs Jones.

- 22 day rehabilitation treatment places have been dedicated to ACT Drug and Alcohol Court Program participants:
  - Directions Health Services 8 to 10 treatment places across combined day rehabilitation and counselling package (12 week program)
  - Toora Women Inc 12 treatment places across combined day rehabilitation and counselling package (12 week program overall with 8 weeks in day rehabilitation).

#### Other treatment options

There are several other AOD treatment and support options for people to access in the ACT with the aim of matching suitable treatments, including:

- Counselling one to one, family and group (may be delivered in-service, or in outreach settings);
- Withdrawal residential and non-residential services (medicated or non-medicated);
- Support and case management;
- Information and education (for example following diversion by police);
- Pharmacotherapy maintenance treatment and treatment support;
- Sobering-up Shelter service;
- Pre-treatment support for residential programs;
- Nicotine Replacement Therapy access through the AOD treatment services;
- Treatment delivered within hospital settings, including services by consultation and liaison staff;
- Non-rehabilitation treatment delivered within correctional centres;
- Treatment delivered in primary health care settings, including general practice;
- Harm reduction services such as provision of sterile injecting equipment and access to the opioid overdose reversal drug naloxone; and
- Adjunct medical services such as Hepatitis C screening, assessment and treatment.

The delivery of some of these services were also impacted by COVID-19. For example AOD treatment services were required to change the treatment delivery method for counselling services, from face to face to on-line.

The ACT Government provided an additional \$518,000, including \$200,000 of flexible funding to the sector, to support alcohol and other drug services respond to demand pressures and to innovate service delivery models due to the impact of COVID-19.

In relation to: Alexander Maconochie Centre - Smoking

Just a supplementary. Accepting what Mrs Kikkert just said, that corrections do, in fact, have a policy that they collect data on the inmates at AMC on whether or not they are smokers, would that not be useful information for Health to have one providing healthcare services to inmates at the prison?

Is it potentially in the initial screening when people first arrive?

MINISTER DAVIDSON: The answer to the Member's question is as follows:-

Justice Health Services does a health assessment on each detainee who is inducted into the Alexander Maconochie Centre. As part of this assessment, a person is asked about tobacco use and other drug use. These questions form part of an overall health assessment and are not asked for the purposes of data collection but rather to understand how smoking may impact other health issues.

The main source of health data for prisoners in Australia, is from the National Prisoner Health Data Collection (NPHDC) which is collected by the Australian Institute Health and Welfare (AIHW) every three years. It presents information about the health experiences of people throughout the prison cycle. AIHW does regular health surveys of prisoners and releases reports titled "Health of Prisoners". According to the AIHW, of prison entrants surveyed in 2018, three in four (75 per cent) reported that they were current smokers.

In relation to: Mental Health services in the ACT

**MR PETTERSSON:** I would be curious, if on notice, someone could answer if there is a mental health service with no waitlist in the ACT?

Emma Davidson MLA: The answer to the Member's question is as follows:-

#### **Canberra Health Service**

There is no wait list for the Access Mental Health Service. Any member of the public can call the service on 1800 629 354 or consult with a General Practitioner (GP) who may write a mental health care plan or send a referral to the appropriate mental health team on their behalf.

All other mental health services are triaged dependent on clinical needs/assessment which influence how long someone needs to wait.

In an emergency, mental health services can be accessed through the Emergency Departments at Canberra Hospital and Calvary Public Hospital Bruce.

#### Office for Mental Health and Wellbeing

There are a wide range of different types of mental health services for people in the ACT. These include crisis and information and support lines, early intervention supports such as headspace, General Practitioner developed mental health plans and clinical care through Child and Adolescent Mental Health Services (CAMHS). The process for access to these services varies widely and while some services operate waitlists others do not.

A number of services operate on appointments rather than a waitlist approach.

General Practitioner developed mental health care plans are available to people with diagnosed mental disorders through long appointments with GPs and may refer people to allied mental health services.

Specialist mental health services will assess people for eligibility and criticality and if eligible will make an appointment with the relevant clinician. Specialised programs such as residential and day programs often have defined referral pathways and consider referrals based on established criteria rather than a waitlist. For group programs, individual assessed need and compatibility of participants are often key factors for access.

The Australian Psychological Society and services such as Lysn aim to assist people to find a psychologist that fits with their needs both via face-to-face appointments and through telehealth options, often without a wait time.

Online supports including group interventions are often accessible without a wait time. There is increasing interest in access to these programs.

The ACT Government recognises the need for continued investment to support the mental health and wellbeing of the ACT community. In the February 2021 ACT Budget, we announced that we are investing over \$19 million into the mental health system. These investments include:

 \$3.156 million for Child and Adolescent Mental Health Services (CAMHS) for continuation of the Adolescent Mobile Outreach Service;

- \$14.1 million to the Police, Ambulance and Clinician Early Response (PACER) program through until 2024;
- \$1.7 million to continue a range of mental health programs and services that were funded by the COVID-19 Mental Health Support Package; and
- \$655,000 to establish two scoping studies for multidisciplinary services for adolescents and young people and to fund an Alcohol and Other Drug Nurse.

In relation to: Emergency apprehensions assessments occurring within four hour timeframe

**MRS JONES**: Okay. And do we know how good we are at achieving the four hours at the moment? Or can you maybe take on notice to get some data back?

Dr Arya: It is very rare that we are not.

MRS JONES: Yes. But I would love to see that in a statistical profile.

Dr Arya: Certainly. We can take that on notice.

Emma Davidson MLA: The answer to the Member's question is as follows:-

Under Section 84 (2) the *Mental Health Act 2015*, a person who is detained under Section 81 must receive an initial examination within four hours of either:

- the person arriving at the facility if the person is apprehended and transported to a facility, or
- the person being detained at the facility if a person is detained following their attendance at a facility.

During the 2019–20 financial year, 2479 people attended the Canberra Hospital Emergency Department under s80 of the *Mental Health Act 2015*. Of those people, 2392 people were seen within four hours.
