Hi Sandra,

Sorry, I don't think I conveyed clearly what I meant for the 2009-2010 year.

If I had made the pledge before this financial year started, it would've been \$40,352. However, given the reduced amount would take effect from 31 August, I'd like to keep the old pledge amount until 31 August.

So, the rough calculations for the 2009-2010 year would be:

- $\$55,700 - \$40,352 = \$15,348$
- So, given roughly 2 months had passed already, the reduction in the pledge would be $\$15,348 / 12 * 10 = \$12,790$.
- Therefore, the new pledge amount for 2009-2010 would be $\$55,700 - \$12,790 = \$42,910$.

However, I image you have a more precise way of working out the exact amount rather than just working off monthly figures (i.e. by using working days).

Would you be able to ammend the 2009-2010 figure accordingly?
