Summary figures of the number of clients engaging the Tenants Union before Legal Aid ACT offered a Tenancy Advice Service are not available to Legal Aid ACT.

The Justice and Community Safety Directorate advises the following:

The Tenant's Union reported to the Justice and Community Safety Directorate in relation to services delivered through the Tenants Advice Service. Their 2019 client survey report provides a holistic summary of the clients supported through the service from February 2016 – June 2019 and is extracted below:
