I would like to make a submission about this bill.

I regularly commute and otherwise travel by bike. Including with multiple children (see for example <u>https://www.act.gov.au/our-canberra/latest-news/2021/july/canberra-electric-bike-library-on-a-roll</u>).

Frankly I was astonished to discover that nothing more than 'negligent driving' was available for the incident that sparked this bill. I had assumed that something like 'negligent driving occasioning actual bodily harm' existed. Apparently not. Driving into people is ok so long as you only hurt them a little bit, it seems.

To that end I think negligent driving occasioning ABH is necessary. It would carry the prospect of gaol time - as is usually the case when one human injures another in pretty much any other context.

This bill however is also necessary. An offence occasioning ABH would require a proper prosecution, which would not always be easy and police may be reluctant to pursue. An 'on the spot' fine of \$1,600 instead of ~\$400 is enough to cause financial pain that will be remembered. It is also more commensurate with the crime - I can be fined \$1,000 for not checking in, on the hypotehtical chance I have COVID and that makes my movements hard to trace, but I drive into someone and cause actual harm and it's only \$400.

I have personally been in this sort of collision in the ACT (about 2015). A car came out of its driveway across the footpath without looking and collected me. I was injured and had to go to hospital, although thankfully nothing permanent. The police attended. They decided not to even issue a negligent driving fine. They seemed to think 'having a chat' with the driver was enough. In literally any other context where I caused enough injury to hospitalise someone, I would be arrested. Unless I do it with a car. Then I don't even get a fine!

So I support this bill. It should be accompanied by a direction to police to issue fines in collisions with vulnerable road users unless there is a reason not to. If someone can go to gaol for sexual assault based solely on the testimony of the complainant, they should be able to get a fine every time they collide with a vulnerable road user, even if the only evidence that would end up in court is the testimony of the complainant.

Once this is passed please introduce negligent driving causing ABH.
