- 2. The procurement framework provides scope for delegates to make a decision that differs from the recommendation of the evaluation team if circumstances warrant. This discretion is specifically allowed because the delegate is expected to use their expertise and judgment, within clearly set out parameters, to ensure the most effective and efficient delivery of procured projects. A delegate may also request that an evaluation team respond to queries or further consider aspects of its initial report before a final recommendation is considered by the delegate.

There is no specific requirement to report information on cases where delegates depart from a panel's final recommendation and no such list has been specifically created by Major Projects Canberra.

Noting the above, and noting that MPC has not undertaken an audit of all procurement processes where an MPC official was the decision-making delegate (as additional time would be required to undertake such an audit) MPC officials are not immediately aware of any procurement process where an MPC official was the decision-making delegate and where that delegate has exercised their discretion to award a tender to a party other than the party that was recommended by the tender evaluation panel in its final recommendation for that procurement.
