## Incident Management

Steps that were taken or will be taken to prevent or minimise this type of incident in the future

I will be preparing a risk assessment, some of which measures have already been put in place with the service. I have liaised with CYPS and requested details under section 863 of the Child and Young People Act, and they have confirmed that they will be sending some packs to Wonderschool through the regulatory authority. There is an integrated meeting planned for next week, Wednesday based on some previous notifications in relation to the child. CYPS have indicated that they have some new allegations that are currently being reviewed to go under appraisal. I spoke to the ACT Ombudsman reportable conduct team on 30 July 2024, that have confirmed the allegations are notifiable under the scheme. I will be preparing an s17G notification and an investigation plan. The investigation plan will be considering the other services and investigations into the conduct that are already in progress.
