Ms Divorty: Sorry, Mr Doszpot, is this related to a move to Winyu house or just in general?

MR DOSZPOT: It is in general ICT. What are the ICT related companies around Gungahlin that you could get further access to?

Ms Divorty: I think it would be too early for us to say that. Generally speaking we use our panels and if an industry member is on the panel then we would use those regardless of whether they are in Fyshwick or Gungahlin or Woden. We would not really differentiate in that. If they are local they are local. But I am not sure that I could answer. I might have to take that on notice if you would like that information but I do not know which companies might be located in Gungahlin.

In regard to our current list of suppliers, we do not collect that information.

MR DOSZPOT: Yes, that is what I am trying to understand.

Ms Divorty: I can take that on notice.

Treasurer, people that hire ACT government facilities such as sporting grounds and the like often bring to my attention costs of insurance, particularly for issues like junior sport. Has any consideration ever been given to providing some sort of blanket insurance which could then be ameliorated through perhaps increasing the ground hire?

Mr Barr: The answer to the Member's question is as follows:-

The ACT Insurance Authority Act 2005 establishes the Authority as a captive insurer providing insurance to ACT Government agencies and entities. The Authority is not a licensed insurer and therefore unable to provide insurance to private entities or persons.

The Australian retail insurance market is able to respond to the needs of sporting groups through the provision of competitively priced blanket insurance cover tailored to their specific needs at Club, State and National level.

This price is the estimates cost (GST Inclusive) for the three year contract term plus two one year extensions and includes mowing of arterial roads, connecting roadways and adjacent open space. The information, including the public text of the contract can be found on the Contracts Register on the Shared Service Procurement website.

The delivery model for the additional mow of the arterial roads has not yet been determined. Should this involve additional work under contract number 2014.23601.210, the price would be determined via negotiation with the contractor under the terms and conditions of the contract.

The 2015-16 Budget will provide \$7.8m over four years to manage the Lower Cotter Catchment, including fire mitigation works (\$5.1m), weed and pest control and erosion and sediment control (\$2.7m).

The Mugga Lane Resource Management Centre facility is licensed to accept a wide range of wastes, including asbestos. In 2005 the Territory established the first dedicated asbestos cell on a closed landfill area. This cell continues to receive asbestos, primarily sheeting and soil contaminated with small particles of bonded asbestos.

No dedicated asbestos sites were established prior to 2005 within the Mugga Lane Resource Management Centre. All landfill cells at the Mugga Lane facility are regarded as contaminated with asbestos and are managed accordingly.

- 1. What is the public area and private area in Kambah shops?
- 2. Who is responsible for the courtyard area at Erindale shops?
- 3. If TAMS is responsible what is the cleaning/maintenance regime for the courtyard?

Shane Rattenbury MLA: The answer to the Member's question is as follows:-

1. In general, the public area at the Kambah Village shopping centre is the land that falls outside of the eaves line of the buildings. All land that is within the eaves line is within the private lease and is the responsibility of the lessee.

The area adjacent to the playground that provides public seating is maintained by TAMS. All public areas are cleaned of litter and excess vegetative material on a daily basis. The seating in the area adjacent to the playground is cleaned as required.

- 2. TAMS are responsible for the main courtyard areas at the Erindale Shops.
- 3. These areas are cleaned on a daily basis with all litter and excessive vegetative material removed from the hard standing areas. The maintenance of the area is undertaken on a cyclic program. Weeds are controlled on a three monthly cycle; mulching and other garden bed maintenance is undertaken through the winter horticultural maintenance program. Seating in the area is cleaned on an as required basis.

Like much of the ACT Public Service, ACTION's injury management performance has improved following the introduction of initiatives-under the Whole of Government Workers' Compensation and Work Safety Improvement Plan.

Compared to the year prior to the commencement of the Improvement Plan, ACTION's 2014-15 year to date results show a 19 per cent reduction in the number of lost time injuries. This compares favourably with the equivalent whole of government result, which improved by around 10 per cent.
