Minister Gentleman: I am advised the answer to the Member's questions are as follows:

The procurement framework provides scope for delegates to make a decision that differs from
the recommendation of the evaluation team if circumstances warrant. This discretion is
specifically allowed because the delegate is expected to use their expertise and judgment, within
clearly set out parameters, to ensure the most effective and efficient delivery of procured
projects.

Delegates are required to document their decisions. Identifying and providing the data for the purpose of this request by the committee would represent an unreasonable diversion of directorate resources.
