Reference: Hearing on 10 November, Annual Report of Minister for Business and Better Regulation.

In relation to: Access Canberra - Mobile Speed Camera Van Speed Limit Signs

- 1. Please provide a month-by-month breakdown of the number and total revenue of mobile speed camera van fines issued for the past 36 months.
- 2. From what date were the speed limit signs no longer displayed on the roof of the mobile speed camera vans?
- 3. Please provide a month-by-month breakdown of the number and total revenue of mobile speed camera van fines since the signs were no longer displayed.

Minister Cheyne: The answer to the Member's question is as follows: -

 The below table provides a month-by-month breakdown of number of offences detected and the sum of penalty amounts issued. Note that the penalty amount does not equate to revenue due to several factors including withdrawn, cancelled, and disputed infringements still being processed. Additionally, revenue does not correlate to the month the infringement was detected and the notice issued.
