This response answers QON12-15 and 24-25.

- (1). Average rates and levies charges for selected suburbs for 2023-24 and 2024-25 is provided in the table below. The figures represent the total of general rates, the Police, Fire and Emergency Services Levy, the Safer Families Levy minus any rebates or deferrals that were applied. It does not include any interest that may have been charged.
- (2). The average land tax charges for properties in the selected suburbs for 2023-24 is provided in the table below. It does not include any interest or penalty tax that may have been charged. As land tax charges are raised quarterly it is not possible to provide the 2024-25 land tax figures until after the last billing run in April 2025.
