**DECISION NOTICE TO CANCEL PROVIDER APPROVAL: PR-40017482**  
**Section 33, *Education and Care Services National Law (ACT) Act 2011 (National Law)***

1. I am satisfied that, Our Place Educational Services Pty Ltd , PR-40017482 is not complying with the provisions of the *Education and Care Services National Law (ACT) Act 2011 (the National Law)* and the *Education and Care Services National Regulations (the National Regulations)*.
2. I have decided to cancel the provider approval under section 31 of the National Law which will take effect 14 days from the date of this notice.

**Facts**

1. On 13 September 2018 you were granted provider approval by the ACT Regulatory Authority for Our Place Educational Pty Ltd, PR- 40017482.
2. It is a condition of this approval that the approved provider must comply with the provisions of the *Education and Care Services National Law (ACT) Act 2011* and the *Education and Care Services National Regulations 2011*.
3. On 18 July 2019 you notified the Regulatory Authority of the surrender of the service approval for Our Place Educational Centre- Evatt, SE-40003612.
4. The provider has not operated a service since the surrender of the service approval.
5. The Authority has had no correspondence from you since in relation to your status as an approved provider or your intentions to apply to for a service approval to operate an education and care service.
6. On 21 June 2022 you were sent a show cause for cancellation of Our Place Educational Services Pty Ltd, PR- 40017482. The Authority did not receive a response; therefore, a decision has been made to cancel the provider approval.

**Law**

7. It is a condition of the provider approval that you must comply with the provisions of the *National Law* and *National Regulations*.

9. The following provisions of the *National Law* and *National Regulations* were engaged:

**Section 31 of the *National Law***

**Grounds for cancellation of provider approval**

A Regulatory Authority may cancel a provider approval if –

...

(f) the approved provider has not operated any education and care service for a period of more than 12 months (including any person of suspension).

**Reasons**

10. It is a condition of this approval that the approved provider must comply with the provisions of the *Education and Care Services National Law (ACT) Act 2011* and the *Education and Care Services National Regulations 2011*.
11. On 21 June 2022 you were sent a show cause for cancellation of provider approval.
12. Since this time, the Authority has had no correspondence from you regarding the application of service approval or your status as an approved provider.
13. Section 31 of the *National Law* identifies that the Authority has grounds to cancel a provider approval if the provider has not operated any education and care service for a period of more than 12 months (including any period of suspension).
14. Since the surrender of service approval on 18 July 2019, you have not operated a service under the approved provider Our Place Educational Services Pty Ltd.
15. Consequently, I have determined that it is appropriate to cancel the provider approval.
16. Based on the evidence before me, I am satisfied that you were aware of your obligations as an approved provider and that you have not taken the required steps to meet these obligations. I am satisfied that the evidence warrants me to issue this cancellation of provider approval.
17. As stated, your approval will be cancelled 14 days from the date this notice is issued.
