- 3. Please list, in order of priority, your three main areas of concern regarding the ACT 2011-2012 Budget?
 - 1. The Budget fail to fund competitive salaries for ACT teachers, counsellors, educational leaders and support staff; in particular, it fails to provide sufficient funds (a) to address the 16% wage difference between ACT Deputy Principals and NSW Deputy Principals, or (b) to implement an effective professional pay scheme based on professional standards
 - 2. The budget fails to provide sufficient funding to support new educators through mentoring programs
 - 3. The Budget fails to adequately increase the level of recurrent funding for the delivery of courses at CIT, or to fund measures to reduce unsustainable workload levels in both schools and CIT.

Comment Overall the Budget represents another lost opportunity for ACT Public Education.

The Government has listened to some of that advice by removing the cost cutting Efficiency Dividend for the Education and Training Directorate for 2011-2012 and providing an extra \$5M a year for disability education, but Government has failed to adequately fund the provision of competitive and attractive salaries in the ACT Public Education System. 7.
