Council's views on the ACT Budget

The ACT Council of Parents & Citizens Associations is the peak body of ACT public school Parents and Citizens Associations. We promote the interests of parents and other school community members to government. Our area of priority is ensuring a strong public education system exists in the ACT.

Council views this year's budget in a generally positive light, however we have serious concerns around some areas and omissions in the budget. Council is particularly concerned with the cuts required of ETD, the relatively low growth in the education budget and the lack of investment in road safety.

Cuts to the ETD Budget

Council understands that this budget requires ETD to make \$6.2 million in savings. Council has long advocated against such cuts. Education, as a frontline service, should be exempt from such cuts, and funding should grow at a minimum to keep pace with inflation and allow for natural increases in the number of school students.

Whilst the cuts are meant to come from within the directorate and not the classroom Council is concerned that such cuts may have a flow on effect to the classroom in the delivery of support provided to teaching staff. If any cuts are to be made it should be ensured that they will not have a flow on effect to the classroom.

Rate of budgetary increase

Despite the cuts Council understands that the total spending on public schooling is still to grow by \$22.3 million an approximate increase of 4%. Council always welcomes growth in the education budget. However school census results released earlier this year showed that for the fifth year in a row enrolment in government schools has increased. Furthermore once CPI and staff wage increases are factored in the effect of the increase will be diminished. Council is particularly disapointed by this small growth in public education spending when compared to the private sector which has seen an 8.1% increase in funding from the ACT and Federal Governments. Public schooling is under-resourced compared to private schooling and we want this imbalance to be redressed, not worsened.

Lack of investment in road safety and school transport options

Council was disappointed to see that the budget failed to adequately address parental concerns over the road safety at schools. Last year, Council conducted a survey that revealed parents were concerned about drivers speeding through school zones, the lack of

pickup/drop off facilities and drivers failing to stop at flagged crossings. In fact road safety around schools was the number one area of concern for our surveyed members. Council proposed numerous initiatives to Treasury to address these issues; more appropriate signage, increased drop off areas and more appropriate crossing facilities.

During the 2012 ACT election, both major parties noted the concerns of parents and Council. Despite this acknowledgement, the government failed to properly address the problem by budgeting for any new initiatives.

Council called on Treasury to make funding arrangements to address school bus services and active travel, as well as road safety. Council recommended that transport should be viewed as a single issue requiring a whole of government response.

Unfortunately no money has been earmarked to conduct the necessary study and network redesign to address these problems.

Provision of education in the Molonglo Valley

Council was pleased to see money had been set aside to finalise the plans for a new Coombs Primary School to service the residents of the new homes in Molonglo. However Council is disappointed that the design is to be completed in 2013-2014 with construction and opening of the school to come much later.

The Molonglo Valley has many new occupied houses. Council is distressed at the apparent lack of provision of public schooling in this large new area given many of the other primary schools in the region are already at, or over capacity. We fear that parents will be forced to avail themselves of private schools and the children denied an inclusive secular education.

Investment in Canteens and Students

On a positive note Council was pleased to see the government is taking the issues facing canteens seriously and is appreciative of the \$200,000 grant earmarked to allow Council to help struggling canteens. This funding will help improve the management of canteens and introduce an online ordering system, turning school canteens into more efficient operations.

Likewise Council is pleased to see money has been earmarked to provide additional support to students with a disability in both the classroom and in getting to and from school. As was noted in the 2013 school census report, enrolment of students with a disability increased by 7.7% in the government sector. The provision of these funds will go a long way towards helping these students achieve their potential.

Council was pleased to see the budget has allocated an additional \$1.8m over 2 years a new centre in Wanniassa to help students from migrant and refugee backgrounds with limited or no English skills.

Parental engagaement in Schools

Council still believes that funding for parental engagement in public schools is vital to deevlop effective school communities which will benefit both students and schools. \$50,000
