Asked by Mrs Elizabeth Kikkert MLA: To ask the Minister for Corrections

In relation to: **The rollout of CORIS**

Ref: Estimates Hearing on Thursday, 25th February 11:00-12:00pm.

During the hearing, Mrs Kikkert asked about the rollout of CORIS

1. At what phase of the rollout is CORIS at?
2. Does ACTCS have a new deadline for when CORIS will be fully implemented?
 - a. If so, when is that deadline?
3. Are there any groups within ACTCS that are already trialling CORIS?
4. Since the signing of the original contract with Abilis for the implementation of CORIS, have there been any variations to the contract?
5. How much has been paid to Abilis so far and for what milestones were they paid?
6. What are the remaining milestones?

Mick Gentleman MLA: I am advised that the answer to the Member's questions are as follows:—

1. CORIS is still in the development phase.
2. It is expected that CORIS will be fully implemented before the end of December 2021.
 - a) Please see above.
3. ACT Corrective Services (ACTCS) are currently in the process of user testing CORIS, prior to its broader deployment. At present there are no groups within ACTCS that are trialling CORIS as part of business as usual activities.
4. Yes, there have been variations to the contract with Abilis. Please refer to the response to Question Taken on Notice No. 23 arising from the inquiry into referred 2019-20 Annual and Financial Reports and Budget Estimates 2020-21 for additional information.
5. To date, \$5.503 million has been paid to Abilis in accordance with the terms of the contract. Payments relate to:
 - achievement against completed milestones; and
 - licensing and administrative costs.
