As an Accredited Mental Health Service, Perinatal Wellbeing Centre (formerly PANDSI) provides perinatal mental health support to clients from pregnancy until their youngest child reaches two years of age. We individually assess each client and develop a tailored plan of support to best meet their needs. In addition to a comprehensive telephone counselling service (supplemented with email support when needed), Perinatal Wellbeing Centre offers a range of programs and workshops designed to provide mental, emotional and physical benefits to those experiencing perinatal depression, anxiety, stress and/or are finding it challenging adjusting to parenting.

It is disappointing to see no funding for perinatal mental health in this Budget. Our organisation is grateful to have received some funding to address the massive spike in demand associated with the lockdown, but nothing to meet ongoing operations as costs increase and needs continue to grow. The toll taken on the mental health of expectant and new parents experiencing bushfires, toxic smoke and a pandemic has been intense, and this has translated into significant increases in the services delivered, and the complexity of client care, for front line services like Perinatal Wellbeing Centre. For some mothers, additional residential clinical support is the most appropriate form of care, yet the ACT has no public mother/baby mental health units. Whilst the Budget includes significant hospital growth, it neglects this vital area of need.
