 - c. financial support for 'personal development',
 - d. and assistance for at-risk young people to commence an apprenticeship by providing them with tools, work wear and equipment to assist with study?
- 2. How many individuals and youth groups received:
 - a. financial support to participate in national and/or international conferences,
 - b. financial support to participate in representative sports,
 - c. financial support for 'personal development',
 - d. and assistance for at-risk young people to commence an apprenticeship by providing them with tools, work wear and equipment to assist with study?

MINISTER BERRY- The answer to the Member's question is as follows:

- 1. Outlined below are details of funding for specific activities through the Youth InterACT Scholarships program.
 - a. In 2020-21, no Youth InterACT Scholarships were funded to facilitate participation at national and/or international conferences.
 - b. In 2020-21, a total of \$2,480 was funded through the Youth InterACT Scholarship program to support participation in representative sports.
 - c. In 2020-21, a total of \$15,211 was funded through the Youth InterACT Scholarship program to support personal development.
 - d. In 2020-21, a total \$500 was funded to support an at-risk young person to purchase equipment in preparation for work experience in the trade sector.

- 2. Outlined below is the number of individuals and groups that received funding for specific activities through the Youth InterACT Scholarships program.
 - a. In 2020-21, no individuals or groups were funded to participate in national and/or international conferences.
 - b. In 2020-21, 2 individuals and one group were supported to participate in representative sports through the Youth InterACT Scholarships.
 - c. In 2020-21, 25 individuals and 2 groups were supported for personal development activities through the Youth InterACT Scholarships. Funded personal development activities included training courses, driving lessons, skills development and educational programs.
 - d. In 2020-21, one individual was supported to purchase equipment in preparation for work experience in the trade sector through the Youth InterACT Scholarship program.
