## **ANSWER TO QUESTION ON NOTICE**

Ed Cocks MLA: To ask the Minister for Industrial Relations and Workplace Safety

Ref: Budget Statement B, Table 4, p. 250 In relation to: Accountability Indicator B - Issuing of Notices

- 1. Of the improvement notices issued for each of the previous three financial years, how many were issued to ACT Government directorates, agencies or workplaces where the person conducting the business or undertaking (PCBU) was an ACT Government employee?
  - a. How many of these workplaces were issued with more than one improvement notice?
- 2. Of the infringement notices issued for each of the previous three financial years, how many were issued to ACT Government directorates, agencies or workplaces where the person conducting the business or undertaking (PCBU) was an ACT Government employee?
  - a. How many of these workplaces were issued with more than one infringement notice?
  - b. How much was paid in fines or penalties due to receiving such infringement notices?
- 3. Of the prohibition notices issued for each of the previous three financial years, how many were issued to ACT Government directorates, agencies or workplaces where the person conducting the business or undertaking (PCBU) was an ACT Government employee?
  - a. How many of these workplaces were issued with more than one prohibition notice during this three year period?
  - b. How many days in total were these workplaces or parts of these workplaces shut down for due to the prohibition notices?
