Asked by Mr Parton on 10 November 2022: Minister Cheyne took on notice the following question(s):

In relation to:

Mr Parton "And finally with you indulgence chair, I don't even know if you've got this detail which I am assuming would have to be taken on notice. What I would love to know is what percentage of fines at this particular zone including the three cameras there on Northbourne Ave have gone to interstate registrations as compared to ACT and how does that breakdown compare with other camera locations across the ACT?"

Minister Cheyne "I can certainly give you the answer to that location and we'll have to take on notice how that compares to other locations and it may well be to calculate if all the other locations Mr Parton might be an reasonable diversion of resources but we will see we will do our very best certainly the information that I have and this is not the financial year so can I just be clear on the dates from the 5 July 2021 to 16 October 2022 that 54.95 per cent were issued to ACT drivers and 45.05 per cent were issued to non ACT drivers and can I certainly note that we have seen the speeds with which people interstate and ACT travelling through there come down and that's being commensurate with fine and infringement notices so in the last quarter from 1 July to 30 September around 99 per cent of vehicles travelling through the intersections were doing so within the sign posted limit."

Mr Parton "Alright thank you and so you yes have taken on notice that detail if it is possible, I have faith in Mr Mangeruca, I have enormous faith, thank you."

Minister Cheyne: The answer to the Member's question is as follows:-
