ANSWER TO QUESTION TAKEN ON NOTICE DURING PUBLIC HEARINGS

Asked by Mr Peter Cain MLA on Monday, 31 July 2023: Ms Bettina Konti took on notice the following question(s):

In relation to: HRIMS Contractors

MR CAIN: I have not asked that. Are you able to provide an updated list of suppliers for the HRIMS program, and in addition, the actual dollar value for each of those contracts?

Ms Konti: Yes, I can.

MR CAIN: Thank you. I note as well that you advised at QON 1157 it took 23 hours and 45 minutes at a cost of \$2,289 to the ACT taxpayer. Minister, why would you take nearly a day to come up with a list of contractors on this one project?

Mr Steel: I will hand that one to CMTEDD to answer. They were collating the information.

Ms Konti: I will have to take that on notice, Mr Cain, and is it okay if I actually correct what I said last time? I think the question for the QON talked about suppliers involved in the delivery of the HRIMS program, and so I think we provided you the list of the suppliers involved in the delivery; rather than necessarily those that might have been involved in the review, which is Yarrabee Consulting. But nevertheless, I will take on notice the supply of all contractors that may have been involved in the HRIMS program.

Mr Chris Steel MLA: The answer to the Member's question is provided in tabular form at Attachment A. The updated list at Attachment A provides a list of all supplier payments related to the HRIMS project. This list includes the use of specialist staff engaged under labour hire arrangements. The May 2023, Geoff Leeper, Yarrabee Consulting report "Positioning For Success in Complex Implementation" cost \$12,500 (exclusive of GST) was not charged to the HRIMS project.
