Recommendations

Recommendation 1

The committee recommends that ACT Government consult with midwives about any operational problems in accessing Syntocinon and report how many orders have been signed by Obstetrics and Gynaecology Consultants for Syntocinon since July 2023.

Recommendation 2

The committee recommends that the ACT Government report regularly on how many emergency room presentations arise from dental issues.

Recommendation 3

The committee recommends the ACT Government increase funding for safe havens and peer workers.

Recommendation 4

The committee recommends that the ACT Government consider whether it can locally support links between on-the-ground food rescue and second-hand and refurbished goods and the community services who need them.

1. Introduction

Presentation of 2022-23 annual and financial reports

- 1.1. Annual and financial reports for the Territory were tabled on 24 October 2023 in the ACT Legislative Assembly. A collated list of annual and financial reports is available online.
- 1.2. During its inquiry, the Standing Committee on Health and Community Wellbeing (the committee) examined all or part of the annual and financial reports for 2022–23 for the following entities:
 - ACT Health Directorate (Health);
 - Canberra Health Services (CHS); and
 - Community Services Directorate (CSD).

Conduct of the inquiry

- 1.3. The committee held public hearings on 14, 15, 16 and 21 November 2023. At the hearings the committee heard from ACT Government Ministers and accompanying directorate officials.
- 1.4. Witnesses who appeared before the committee are listed at Appendix A. Transcripts and footage from the hearings are available on the Legislative Assembly website.

Questions Taken on Notice and Questions on Notice

- 1.5. A total of 106 questions were lodged during the inquiry, as follows:
 - 50 questions were taken on notice by Ministers and statutory office holders during the hearings. One was later determined to have been answered during the relevant hearing.
 - 56 questions on notice were submitted by members of the committee and visiting
 Members of the Assembly following the hearings.
- 1.6. A list of questions (including the date the question was asked, the intended recipient, and the subject of the question) is set out in Appendix B. Also included is the date on which a response was received.
- 1.7. Responses to questions on notice and questions taken on notice are also available on the committee's website.
- 1.8. A breakdown of witnesses who appeared at the public hearings by gender identity is given at Appendix C.

2. Health portfolio

- 2.1. The ACT Health Directorate (Health) provides the strategic direction and leadership of the ACT health system. It sets the policy and plans delivery of health services through a range of functions, including but not limited to:
 - Engagement with other jurisdictions, including the Commonwealth, on health initiatives, whole of government policy, and funding;
 - Delivering a range of health prevention, promotion and protection services;
 - Administering the ACT Government's legislative program on health matters; and
 - Planning and evaluating health system performance, workforce, infrastructure and training.³
- 2.2. Canberra Health Services (CHS) provides acute, subacute, primary and community-based health services to people across the ACT and surrounding Southern NSW Local Health District. It administers a range of publicly funded health facilities, programs and services, including but not limited to:
 - Canberra Hospital, North Canberra Hospital, and the University of Canberra (UC)
 Hospital;
 - Six community health centres;
 - · Five nurse-led walk-in centres; and
 - Community-based health services.⁴
- 2.3. Health and CHS officials appeared together across two days of public hearings for this inquiry.

Health and Health system

- 2.4. Ms Rachel Stephen-Smith MLA appeared before the committee on 16 November 2023 in her capacity as Minister for Health. The following matters were discussed:

- v) the early pregnancy service²⁶
- w) provision of gynae-oncology and maternal and child health services 27
- x) work to support the national climate change and health strategy announced by the Commonwealth Government²⁸
- y) radiotherapy equipment.29

Key issue

Homebirths

- 2.5. The Centenary Hospital for Women and Children's continuity midwifery program offers a publicly funded Homebirth Service to eligible women in the ACT.³⁰
- 2.6. During public hearings, the committee raised concerns regarding reports Members had received from midwives experiencing issues accessing Syntocinon for homebirths.³¹
 Officials advised CHS was 'reviewing maternity services' access to continuity midwife models' to help identify barriers that may drive women to deliver in a hospital setting.³²
- 2.7. In a response to a question taken on notice, the Minister advised:

...prior to 2022 midwives obtained signature on the Homebirth medication from an Obstetrics and Gynaecology Consultant during a collaborative clinic for women planning a homebirth. Some challenges were experienced with the process of signing the medication order following staffing changes in the collaborative clinic, however these have now been resolved. At no time were any women prevented from accessing homebirth due to unsigned medication orders or dispensing of medications.

- 2.8. The committee understands Syntocinon is part of the homebirth medication order set and can be dispensed to eligible patients after a midwife has obtained an Obstetrics and Gynaecology Consultant signature on the homebirth medication order form.³³
- 2.9. The Minister advised that:

Since July 2023, midwives can prescribe Syntocinon for the indication of 'active management of the third stage' under an approved Canberra Health Services medication standing order. Midwives must have the initial order signed by an Obstetrics and Gynaecology Consultant to enable dispensing from pharmacy. There have been no concerns reported in the past three months to November

2023 of midwives having difficulty getting homebirth medication orders signed to enable dispensing by pharmacy.34

Committee comment

2.10. The committee welcomes the Minister's advice that midwives can now prescribe Syntocinon after an initial order has been signed by an Obstetrics and Gynaecology Consultant and that Government has not received any reports of midwives having difficulty in getting these orders signed.

Recommendation 1

The committee recommends that ACT Government consult with midwives about any operational problems in accessing Syntocinon and report how many orders have been signed by Obstetrics and Gynaecology Consultants for Syntocinon since July 2023.

Dental services

- 2.11. In 2022–23, CHS provided dental services to 6,623 adults and 6,091 children, at a cost of \$11.807 million.35
- 2.12. During the public hearing, the committee queried the lack of information in annual reports regarding dental services provided by CHS.36 In response to a question taken on notice, the Minister advised '[i]nformation related to public dental services is reported nationally by the Australian Institute of Health and Welfare (AIHW)'.37
- 2.13. Data provided in the AIHW Oral health and dental care in Australia web report provides national data up to the 2021–22 financial year. Data for hospitalisations by state is available for 'potentially preventable hospitalisations' and 'dental procedures requiring general anaesthetic.' The report states there were 1,516 potentially preventable hospitalisations in the ACT in 2021–22 due to dental conditions.³⁸

Committee comment

2.14. In light of the data reported by the AIHW, the committee considers there would be benefit in providing visibility of the number of hospitalisations due to dental services, including emergency room presentations.

m) the independent review into a major incident at the Canberra Hospital Adult Mental Health Unit in 2022⁵¹

Key issues

Safe havens and peer workers

- 2.16. The ACT Government opened Safe Haven Belconnen in November 2021. The Safe Haven is staffed by a peer workforce and offers a non-clinical space for people experiencing emotional distress, mental health concerns, isolation or loneliness seeking connection and support.⁵²
- 2.17. The Minister spoke to the success of Safe Haven Belconnen, noting the service which utilises peer workers helps to divert people away from emergency departments and assists people to manage chronic mental health conditions.⁵³
- 2.18. Planning has commenced on a second Safe Haven to be located on the Canberra Hospital campus and will draw on lessons learned from the Safe Haven Belconnen program. ⁵⁴ The ACT Government announced \$2.3 million over four years for a second Safe Haven in the 2023–24 ACT Budget. ⁵⁵
- 2.19. The committee heard of the important role peer workers play in supporting a wide cross-section of the community through Safe Haven Belconnen:
 - ...We are talking about a really diverse range of people who are accessing these services and finding that it is helping them. That really speaks to the value of having services with peer workers who themselves are representative of the diversity of people in our broader community who might need to access those things. That is a really good, positive sign.⁵⁶
- 2.20. The Office for Mental Health and Wellbeing advised it was seeking to increase training and opportunities for peer workers in the ACT in line with the *Office for Mental Health and Wellbeing Work Plan 2023–2024.*⁵⁷

Committee comment

2.21. The committee recognises the benefits peer workers and non-clinical services such as Safe Haven offer to Canberrans experiencing mental health concerns and to the management of demand on emergency departments.

Recommendation 3

The committee recommends the ACT Government increase funding for safe havens and peer workers.

3. Community Services Directorate

- 3.1. The Community Services Directorate (CSD) is responsible for delivering a wide range of human services functions in the ACT including multicultural affairs; children and child development; youth and family support services and policy; therapy services; disability policy and services; homelessness; and community services.58
- 3.2. Officials appeared on two days of public hearings for this inquiry.

Families and Community services

- 3.3. Ms Emma Davidson MLA appeared before the committee on 14 November 2023 in her capacity as Assistant Minister for Families and Community Services. The following matters were discussed:
 - a) Ministerial responsibilities and conduct⁵⁹
 - b) development of a social recovery framework for future emergency events⁶⁰
 - c) youth justice health programs and services following the raised age of criminal responsibility⁶¹

- d) Child and Family Centre client satisfaction results⁶⁹
- e) the establishment of a new therapeutic support system to support raising of the minimum age of criminal responsibility⁷⁰
- f) review of the Internal Review of Decisions Pilot71
- g) the stage 2 review of A Step Up for Our Kids72
- h) staffing vacancies and impacts on Child and Family Centre services 73
- i) support for foster and kinship carers, including the Carer Wellbeing Joint Committee74
- j) support accessed at Ruby's House.75

Key issues

Circular economy

- 3.5. The ACT *Circular Economy Strategy and Action Plan 2023–2030* sets out the high-level ambition and actions to progress the ACT's efforts to become a more circular economy. ⁷⁶
- 3.6. Actions include consultation with business and industry peak bodies to reduce food waste.⁷⁷ When asked whether CSD would be involved in these discussions, the committee heard there are a couple of mechanisms of government which could offer opportunities for the directorate to work across government:

For example, the processes that are involved in the development of cabinet submissions mean that everybody who has an interest in those cabinet submissions would get to see and comment on those submissions as they are development and to advise or brief ministers prior to a discussion in either a cabinet subcommittee or the cabinet room itself. There are also a number of mechanisms that support the deliberations of cabinet. For example, the human services subcommittee...includes directors-general across all the human services streams. We often have discussions on issues like this to identify where portfolios overlap and where opportunities might exist for us to work together.⁷⁸

Committee comment

3.7. The committee considers greater collaboration across government directorates would provide opportunities to link waste reduction efforts under the circular economy strategy with community support organisations.

Recommendation 4

The committee recommends that the ACT Government consider whether it can locally support links between on-the-ground food rescue and second-hand and refurbished goods and the community services who need them.

Homelessness and Housing services

- 3.8. Ms Rebecca Vassarotti MLA and Ms Yvette Berry MLA appeared together before the committee on 15 November 2023 in their capacity as Minister for Homelessness and Housing Services and Minister for Housing and Suburban Development respectively.
- 3.9. Minister Vassarotti spoke to the following matters:
 - a) the commissioning process for the provision of homelessness services in the ACT⁷⁹
 - b) complaints regarding disruptive and anti-social behaviour⁸⁰
 - c) support for homeless Canberrans and ACT Housing tenants during extreme weather events81
 - d) ACT Housing transfer applications82
 - e) Support services available to men escaping domestic and family violence.83
- Minister Berry spoke to the following matters: 3.10.
 - a) repairs and maintenance undertaken by ACT Housing in 2022-2384
 - b) an update on the external review of total facilities management⁸⁵
 - c) construction of new public housing dwellings86
 - d) transition of government-run public housing properties to headleases with community housing providers in 2022-2387

- e) construction of public housing dwellings since 2017-1888
- f) ensuring accessibility in public housing dwellings, including through the ACT Public Housing Renewal Program⁸⁹
- g) the waitlist for ACT Housing transfer applications⁹⁰
- h) the East Lake redevelopment⁹¹
- i) block utilisation and dwelling types for future ACT Housing properties.92

Key issue

Public housing in East Lake

- 3.11. In 2004, the East Lake area of the Causeway was identified for possible future redevelopment as part of the 2004 Canberra Spatial Plan. Since then, the ACT Government has undertaken community consultation and planning and released its final place plan for the East Lake precinct in February 2024.
- 3.12. In February 2009, public housing residents at the Causeway were assured by the then Minister for Housing, Mr John Hargreaves MLA, that they would have the first offer of public housing accommodation in the redevelopment.⁹⁵
- 3.13. When asked whether public housing would be included in the East Lake redevelopment, Minister Berry advised the project had 'changed from its initial aspiration' due to complications regarding the electrical substation on one of the sites. 96 CSD advised the committee that it would contribute 'in terms of what the places could be for public housing' however the Suburban Land Agency was leading the redevelopment project.

Committee comment

3.14. Given the historical connection of public housing residents in the Causeway, the committee considers it is important to ensure sufficient public housing for those 46 former residents that wish to return to East Lake following completion of the redevelopment.

Recommendation 5
