P01,

I have received a report that an allegation of child abuse against P01 by P01 at the centre has been made to CYPS. The report states that P01 threatened to break P01 arm off and she threw her onto the bed multiple times.

I am beyond devastated.

P01 had expressed things verbally which I bought up including saying P01 had held her down and wouldn't let her have her dummy - (the report also stated that P01 ripped P01 dummy out and despite being told that I was happy for her to have her dummy during sleep time P01 said "I don't care") with P01 and she disregarded them and said she had no idea what P01 was talking about.

The report also states that when it was reported to yourself that you said "it's your word against hers/ours".

I'm now wondering if P01 illness was stress related. As the timing all correlates with the report of abuse.

You did state you would unenrol P01 a few weeks ago so that my days wouldn't get used up while she was sick for so long, but it appears on the Centrelink app that she is still enrolled.

I am sending this email to give immediate notice of the enrolment for both children ceasing.

I now need to take steps to get counselling and support for P01.

This has been utterly devastating. I am trying to process it and also reassure P01 I am aware and now sorry I am for not being there to protect her.

This was the last thing my little babies and family needed. I truly trusted Rainbow. Although I had kept her home longer as there was so many changes that I was having concerns but never could have imagined just how awful things were allegedly to have been.

I also found P01 to be totally suffocating and she refused to let me connect with P01 at the end of every day. Following us inside to outside and back and answering any question I ever asked P01 about her day. This is part of the reason I ended up not bringing her back as I realised how our beautiful close connection returned when she wasn't at the centre. Now knowing everything else - so much is making sense. Including the fact that P01 would say "I'm scared run away and hide" and hide under the table at childcare. Not something she does at home unless she is playing and quoting the baby shark song. She has only done it in public if she feels overwhelmed.

I want to know the outcome of the investigation into this staff member/s. Their cruelty towards my child who already suffers developmental delays due to P05 and therefore she finds it harder to communicate in the first place. But since talking to her she has been very verbal about what has occurred. I am infuriated.

There are a few other things I have also been told which are extremely upsetting. I am still processing these and deciding on the best course of action.

The fact that this event was not reported me as is the legislation - within 24 hours - after you were made aware is alarming to say the least.
