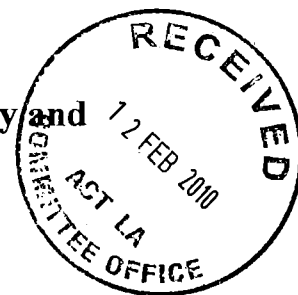

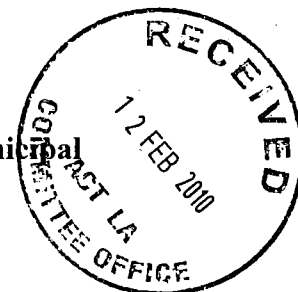

Question: Ms Porter asked Minister Barr about the inclusive framework.

Answer: The purpose of the Sport and Recreation Inclusion Framework is to improve sport and recreation opportunities for people with a disability in the Territory. This will be done by creating links within the disability, education and sport/recreation sectors, as well as increasing inclusion within sport and recreation providers in the ACT.

Extensive consultations for the Framework were undertaken by Sport and Recreation Services (SRS) and commenced in early 2009. A total of 44 organisations participated in the consultation process, including representatives from the ACT sport, disability sport, education and disability service sectors.

The first draft of the framework was provided to SRS in July 2009. Further stakeholder input was then sought and the framework is currently being finalised.
