Tuesday 3August

Visit to the National Center for Missing & Exploited Children, (NCMEC), in Alexandria, Virginia

NCMEC is a private, nonprofit organization founded in 1984. Its aim is to be a point of coordination and research in relation to missing and sexually exploited children. Since its foundation the co-ordination of missing person has been completely transformed. NCMEC is a leader in technology for "aging" missing people so that accurate information is sent out to help in identification and discovery. NCMEC has partners across the US including the FBI, the American Postal Service and Custom Service, law enforcement agencies both civilian and military; and international partnerships including with Interpol and the AFP. As well as its national office in Alexandria NCMEC has offices in New York, Texas and California.

I was invited to a visit to the national headquarters and a briefing by the Chief Executive Officer Ernie Allen who had spoken on human trafficking issues, especially as they relate to internal trafficking of minors in the USA, at the NCSL legislative summit.

Mr Allen offered me a tour of their facilities and a full briefing on the operation of the Centre, their technology and their mandates from federal and state legislatures. I received a briefings on current activities from Mr Allen, Caroline Humer, Senior Program Manager and a range of law enforcement officers seconded to the centre from the FBI, the US Postal Service and the Naval Criminal Investigation Service.

Of increasing interest and attention is the problem of minors who are trafficked for sexual exploitation domestically in the United States. It is estimated that 160,000 minors are trafficked in this way every year. The briefing ranged over current legislative moves such as listing people who traffic minors for sexual exploitation on sex offenders' registers; initiatives in creating missing children resources and a practical demonstration of how their technology and techniques.
