5. Please detail your views on the ACT Budget in relation to your three prority areas?

- 5.a Support for those dealing with financial hardship includes funding for emergency financial and material aid; an appropriate and effective concessions system and access to affordable housing.
- The 2015-16 ACT Budget failed to provide additional support for emergency financial and material aid (EFMA) for people in Canberra despite reductions in this support from the Australian Government. This is despite years of advocacy for additional funds that are required to meet demand. We remain concerned that the delay in the review of the EFMA program throughout a difficult time in the ACT economy has and will negatively impact those who are already most vulnerable.
- It is positive that the budget grows the current investment in the concessions scheme for a further year. We note that this is in the context of the current review and the intention to undertake additional research into reform and increased targeting. It is important that this research and any subsequent reform takes into consideration the recommendations of the Targeted Assistance Strategy, which include a focus on increased and more effective access to concessions for those who need them.
- The renewal of public housing stock is a significant and positive step. It will create a better and more inclusive stock of housing, and increase the quality of living for those in public housing. We are disappointed that there is no expansion in the overall number of people who are able to access public housing by this initiative. Homelessness in the ACT and access to affordable housing remains central to the quality of life of many vulnerable Canberrans.
- 5.b The current review of the Out of Home Care System in the ACT, as reflected in the Step Up for Kids procurement process, includes short term funding for the transition from the current system to whatever will be procured in the near future. It is important that this process recognises and resources the role of early intervention and prevention work that begins at the universal level and flows seamlessly into more targeted services in a way that is consistent with the implementation of the Blueprint for the Human Services System. Failure to resource the universal services will undermine the intention to reduce demand for intensive service provision in the longer term.
- 5.c The provision of funding for the Better Services Program and the Community Reform Program is welcomed. Extended funding for the One Human Services Gateway and the Strengthening Families program will need to be well targeted and effectively applied to ensure that outcomes are consistent with the intention of the Blueprint for Human Services. We do not believe that the continuation of a .34% levy on the community sector for the reform program is appropriate. This levy significantly impacts on community sector organisations who are required to absorb increasing costs as funding in the sector is 'rolled over' for another year. Along with others in the sector, we do not believe there is evdence that the imposition of this levy has produced results of benefit to the sector.
