

Freedom of information request

I refer to your application below, for documents under the *Freedom of Information Act 2016* (the Act), received by the Office of the Legislative Assembly (OLA) by email on 20 November 2018, in which you sought access to "final briefing notes and documents prepared for the 2017-18 Annual Reports hearings".

I am an Information Officer appointed by the Clerk of the Legislative Assembly of the ACT under section 18 of the Act to deal with access applications made under Part 5 of the Act.

OLA is required to provide a decision on your access application by 18 December 2018.

Decision on access

Under section 51(1) OLA is required to give you written notice of the decision on your application.

A search for documents within the scope of your request has identified no final briefing notes or documents were prepared for the 2017-18 Annual Report hearings.

Therefore, under section 35 (1)(b) of the Act, I have decided that the information you have requested is not held by OLA.

For your information, OLA does not routinely prepare briefing notes or documents for its appearance at Annual Report hearings each year. Instead, it has been the practice of OLA and successive Speakers to have an oral briefing prior to the hearing to discuss possible areas of inquiry. No briefing materials are produced by OLA as a result of this discussion.

Online publishing – disclosure log

Under section 28 of the Act, the Office of the Legislative Assembly maintains an online

record of access applications called a disclosure log. Your application, together with my decision, will be added to the disclosure log.

Ombudsman review

You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the date of my decision, or a longer period allowed by the Ombudsman.
