Asked by Mr Mark Parton MLA:

In relation to: The Budget Statement (page 18, table 8), how much is allocated for sportsgrounds?

MR PARTON: Okay. Can you tell us what amounts within—so budget statement 8, page 18, are you able to tell us what amounts are within the figures at table 8 on page 18, are allocated for sporting grounds and also for recreational facilities. So where these are different from sporting facilities because I am gathering that there is some delineation between sporting grounds and recreational facilities but I am not sure whether that is correct.

Output 2.4: City Maintenance and Services

Planning and management of the Territory's parks and urban open space system including associated community infrastructure, maintaining the look and feel of the city, and managing the urban forest and sportsgrounds facilities. The Directorate also provides advice, education and compliance services in relation to municipal ranger functions, domestic animal management, plant and animal licensing and significant tree protection. This output also includes Yarralumla Nursery and Birrigai.
