QUESTION ON NOTICE

Asked by Mr Mark Parton MLA: To ask the Minister for Transport and City Services

TCCS Annual Report 2020-21, Page 188 - Transport Canberra Operations, Operating Statement.

- In relation to the Operating Statement Expenses columns at page 188, for employee expenses and superannuation expenses, could the Minister advise how much of each of these lines was for:
 - a. ACTION bus driver's salaries, wages and allowances;
 - b. ACTION bus maintenance staff salaries, wages and allowances;
 - c. ACTION bus services administrative, management and other staff salaries, wages and allowances;
 - d. ACTION bus services other staff related overheads including any from suppliers expenses for a. to c. above; and
 - e. Any other TCO transport services' staff salaries, wages and allowances?
- 2. In relation to the Operating Statement Expenses at page 188, could the Minister advise how much of each of these lines (for each column) was for:
 - ACTION bus fleet supplies and services including repairs and maintenance, fuel, vehicle hire, spare parts, contract services and all other operating costs charged to supplies and services;
 - b. Depreciation and amortisation related to the ACTION Bus Service;
 - c. Borrowing costs related to the ACTION bus service;
 - d. Expensed capital works in progress related to the ACTION bus service; and
 - e. Other TCO transport services operating costs other than for those requested in Questions 3 and 4 below?
- 3. In relation to the Operating Statement Expenses at page 188, could the Minister advise how much in each of these lines (for each column) was for provision of transport by privately contracted bus services including coaches and the like?
- 4. In relation to the Operating Statement Expenses at page 188, for Canberra Metro, could the Minister advise how much (in each column) is for:
 - a. The construction repayment;

- b. Operations and Maintenance;
- c. Other expenses paid to Canberra Metro; and
- d. What expense lines in the operating statement are the above contained in?
