Inquiry into Disability Inclusion Bill 2024 ANSWER TO QUESTION ON NOTICE

- (1) Before presenting the Bill to the Assembly, was it reviewed by the government?
- (2) In your consultations, was the operationalization of the Bill as enacted considered?
- (3) In the Bill there is mention of a number of consultations across a range of areas that are to be conducted, however in a small jurisdiction that is the ACT, it is generally the same people who participate, has consideration been given that this equates to something like 20+ strategies and plans to be developed?
- (a) Have you considered consultation and submission fatigue of the community?
- (4) Has there been a consideration of who would support the implementation of the bill?
- (5) Have you considered the financial implications of supporting the implementation across a number of Directorates?
- (6) There is the implication that private sector entities may also have to implement these matters, has consideration been given as to how that is to be monitored?
- (a) What supports will be available to train people to be able to implement these matters?
- (7) Has consideration been given to including different types of disabilities, especially as not all those living with a disability qualify for

inclusion into the Disability community, such as those with dementia, or people with cognitive or neurological disabilities?

- (8) Will funding be available for the members of the Disability Advisory Council?
- (a) What about for those who are being consulted with?
- (9) What will be the role of the current Disability Reference Groups?
- (a) How do you see the two entities interacting with each other?

Ms Suzanne Orr MLA: The answer to the Member's question is as follows:-

- (1) Questions concerning the actions taken by Government are best put to the Government.
- (2) The Bill has been developed to reflect and expand on current practice which is proven and well respected.
- (3) Yes, and I draw the members attention to the submissions to the inquiry which raise this matter and the potential responses proposed by witnesses as well as my own testimony.
- (3a) Yes, and I draw the members attention to the submissions to the inquiry which raise this matter and the potential responses proposed by witnesses as well as my own testimony.
- (4) Feedback during the public consultation period as well as submissions and evidence to the Committee Inquiry indicate strong support for the Bill.
- (5) As per all budgetary considerations, Budget Cabinet will determine the funding provisions.
- (6) The monitoring and compliance processes for the Bill are set out in the Bill.
- (6a) This is a matter of implementation and will be a decision for the administering Directorate.
- (7) The question implies there is an eligibility requirement under the Bill which there is not. The Bill is focused on systemic institutional change across a range of organisations, the benefits of which will apply to everyone not just specific individuals.
- (8) Funding for Ministerial Advisory Councils is a decision for Government.
- (8a) This is a matter of implementation and will be a decision for the administering Directorate.
- (9) The Disability Reference Group will be elevated to a Ministerial Advisory Council.
