Inquiry into the Administration of Bail in the ACT ANSWER TO QUESTION TAKEN ON NOTICE

Asked by Dr Marisa Paterson MLA on 18 June 2024: Mr Shane Rattenbury MLA took on notice the following question:

Reference: Hansard [uncorrected] proof transcript [18 June 2024] [PAGE 27]

In relation to:

DR PATERSON: Is it also possible—I do not know whether to ask you or ACT Policing to put on notice the detail of those justice—like a breakdown of those justice procedures.

Mr Rattenbury: I do not know if they are able to extract that from PROMIS but I am happy to take it and be able to coordinate with ACT Policing to provide an answer.

DR PATERSON: Great, thank you.

Mr Rattenbury: I do not know what the answer will be and whether they have it, but we will check.

[Mr Shane Rattenbury MLA]: The answer to the Member's question is as follows:

ACT Policing have provided a breakdown of the Justice Procedures included in the ACT Policing submission.

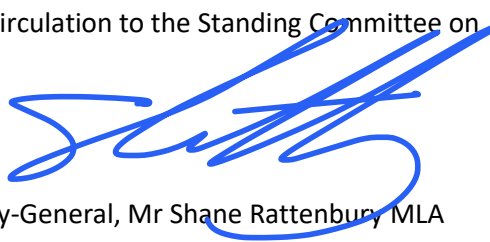
Note that these are *procedures to support police apprehension and appearance before court* and not all of these are a criminal offences. For example breaching bail and other community based orders is not an offence, but these are recorded by police as *Offences against justice procedures and orders* which is consistent with the Australian and New Zealand Standard Offence Classification used by Australian jurisdictions <https://www.abs.gov.au/statistics/classifications/australian-and-new-zealand-standard-offence-classification-anzsoc/2023/14>
