On Tuesday afternoon during the after school program, **P01** (child) required individual support and close supervision from approximately 4:40 pm until 5:00 pm.

P01's behavior quickly escalated following interactions with other children over toys. The actions included; using a stick, in a stabbing motion, towards another child, but not resulting in physical contact or injury. Using verbal threats of harm towards other children, and throwing objects at other children (a milk box, and soft fall mulch) but not resulting in physical injuries.

P01 (Nominated Supervisor) shadowed **P01** during this timeframe, using her body as a barrier between **P01** and other children. **P01** guided **P01** inside the Hall to the piano, as a self-regulation strategy for **P01**.

P01 played the piano for about 20 minutes with no further incidents for the remainder of the afternoon program. (Refer to the attached incident form for more details).

P01's guardian, **P01** **P01** was notified on her arrival at 6:00 pm.

CS#1 continues to work with all care providers to support **P01**, and other children attending the Mawson out of school care program to ensure children's health and safety and appropriate behavior guidance is being provided.

P01 is continuing to record data behavior observations to assist with identifying any triggering actions or patterns for the children, and has engaged with the Inclusion Support services.

CS#1 have engaged with **P01** **P01** to provide tailored training to the staff to manage challenging behaviors. **P01** is scheduled to observe the after school care program on Wednesday 9th September.
