**Show Cause Notice – Proposal to cancel provider approval: PR-40002225**  
**Section 31, *Education and Care Services National Law (ACT) Act 2011 (National Law)***

Dear Mr [REDACTED] and Ms [REDACTED],

As a delegate of the ACT Regulatory Authority (the Authority), also known as Children's Education and Care Assurance, I notify you that I am considering cancelling the provider approval for [REDACTED] and [REDACTED] As Trustees for the [REDACTED] Trust, PR-40002225.

Consistent with Section 31(f) of the National Law, I am considering the cancellation of the provider approval on the following grounds:

1. The Regulatory Authority reasonably believes that the provider has not operated any education and care service for a period of more than 12 months (including any period of suspension).

Evidence supporting the grounds

2. On 4 July 2014 you were granted provider approval by the ACT Regulatory Authority for [REDACTED] and [REDACTED] As Trustees for the [REDACTED] Trust, PR-40002225.
3. It is a condition of this approval that the approved provider must comply with the provisions of the *Education and Care Services National Law (ACT) Act 2011* and the *Education and Care Services National Regulations 2011*.
4. On 11 June 2019 you were sent a show cause for cancellation of Service Approval for Fun Fit Sports, SE-40002447. The Authority did not receive a response, therefore on 6 January 2020 you were sent a service cancellation notice.

5. Since 6 January 2020 you have not operated any education and care service, providing grounds for cancellation of provider approval.
6. The Authority has had no correspondence from you since this time, in relation to your status as an approved provider or your intentions to apply to for a service approval to operate an education and care service.

Notice under Show Cause

Under section 32 (2)(c) of the National Law, you may provide a written submission to me about the issues.

Under section 32 of the National Law, any written submission you make within the time stated in this show cause notice will be considered by me before I make a decision regarding whether to cancel your provider approval. . If no submission is provided within the 30 day period, I may make a decision under section 33 of the National Law.
