## Incident Management

Steps that were taken or will be taken to prevent or minimise this type of incident in the future

Detailed description of the incident including nature of risk, time, cause, etc.

While attending after school care yesterday **P01-P01** a 7 year old was involved in an incident with two other boys at our program.

**P01-P01** was playing on a supervised Playground and was asked to go over to one of the boys. The two boys and **P01** discussed where they could sneak off to be out of sight of our educators.

They found a spot around a corner near the Playground. The boys proceeded to **P05** **P01** to **P01**. Apparently at that point one of the boys involved asked **P01** to **P05** **P01** has admitted that she did but **P05** **P01** was allegedly going to **P05** but they were interrupted by an educator who brought the children inside. I discussed the incident and established the details with all three children and another educator present.

We believe the boy who initiated this incident was inspired but an event last week where **P01** had **P05** to some children during school hours. This previous incident occurred during school hours and was reported by both the school and myself previously to CYPS.

Yesterday I (director) disclosed the incident to both boys parents and had discussions regarding appropriate responses for them and education around appropriate behaviour and the reason we call these area private parts. Both parents were receptive and agreed to keep an ongoing dialogue regarding any further issues or concerns.

In regard to **P01-P01** this is was a further example of behaviour that has increased in it's **P05** nature from holding hands and attempting to **P05**

Yesterdays incident was reported immediately to Namadgi School senior staff whom we have an ongoing open dialogue with regarding such issues. Playbase has notified CYPS this morning the 9/11/22 of the above incident.

Both our service and the school are working collaboratively with **P01-P01**'s mother to provide advice and resources to address this concerning behaviour patterns **P01-P01** has been displaying especially this most recent behaviour.

Her mother has booked her in for a Doctor's assessment and the school is providing some extra support. Our service has made itself available for any other assistance it can provide going forward with CYPS, The School and the families involved.
