In relation to: Growth and Renewal Program and revenue of Housing ACT properties

- 1. For the financial years 2014-2015 to 2022-2023 (inclusive), for the Housing Growth and Renewal Program Part 1 (2015-19) and Part 2 (2019-24) please provide the following:
  - a. The cost of all acquisitions that were part of the program
  - b. The cost of all constructions that were part of the program
  - c. The cost of all land purchases that were part of the program.
- 2. For the financial years 2014-2015 to 2022-2023 (inclusive) broken down by financial year, please provide the total value of all revenue raised on end-of-use Housing ACT properties.

Minister Berry: The answer to the Member's question is as follows: -

## EPSDD managed the Public Housing Renewal Program from 2015-16 to 2018-19

1. The following answer is provided in relation to the Public Housing Renewal Taskforce, and associated initiatives, components related to the "Housing Growth and Renewal Program". This taskforce was concluded in mid-2021.

a/c. The total cost of acquisitions and land purchases as part of the work undertaken by the taskforce was \$159.377 million

Unfortunately, records do not split this between land purchases and acquisitions, with all acquisitions for the program included together

- b. The total construction spending, incorporating costs up to the transfer of the properties to ACT Housing was **\$296.852 million.**
- 2. The break-down of total sales under the renewal program for Suburban Land Agency and Environment, planning and Sustainable development is detailed below.

## Housing ACT manages the current Growing and Renewing Program:

Answer 1(a): the cost of all 'dwelling' acquisitions that were part of the program:

**2019-20**: \$20.2 million; **2020-21**: \$34.3 million; **2021-22**: \$5.1 million; and

2022-23 Year to Date July 2022: \$0.7 million.

Answer 1(b): The cost of all constructions that were part of the program:

**2019-20**: \$23.4 million; **2020-21**: \$40.9 million; **2021-22**: \$71.5 million; and

2022-23 Year to Date July 2022: \$5.9 million.

Answer 1(c): The cost of all land purchases that were part of the program:

**2019-20**: \$8.7 million; **2020-21**: \$43.7 million; **2021-22**: \$6.4 million; and

2022-23 Year to Date July 2022: \$0.0 million.

Answer 2: Sales (gross sales) by Housing ACT on end of use Housing ACT Properties

2014-15: \$40.9 million; 2015-16: \$39.9 million; 2016-17: \$33.0 million; 2017-18: \$52.7 million; 2018-19: \$35.2 million; 2019 20: \$45.7 million; 2020-21: \$121.2 million;

2021-22: \$139.3 million; and

2022-23 Year to Date July 2022: \$11.5 million.
