Hi Anna – below is the response received back from the Office of Water on this. Please let me know if there is anything further you need on this at this time:

- The ICRC are at an advanced stage in their review of the Water Abstraction Charge. A draft report has been provided to EPSDD and Treasury for feedback.
- A final report from the ICRC is due on the 29 February 2024.
- The Non-potable water review Government response is pending the outcome of the ICRC's review of the Water Abstraction Charge and Government's consideration of the ICRC's advice. We will update our advice on the timing of the Government Response once the final review report has been issued.
- We are working closely with Treasury staff on the ICRC review, preparation of an Information Brief on the review outcomes, and refinements to the proposed Government Response.
