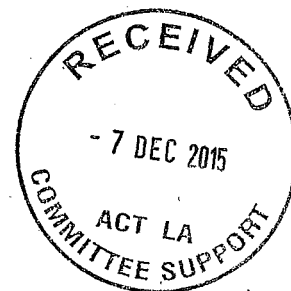

Dear Mr Smyth

I am writing to inform you of my intention to table a corrigendum to the Government Response to the Standing Committee on Public Accounts *Inquiry into Elements Impacting on the Future of the ACT Clubs Sector* following an error in the original response.

Recommendation 22 of the Government Response includes a reference to Professor Bryan Rodgers; Director of the Centre for Gambling Research at the ANU, stating the Professor was the current recipient of a National Health and Medical Research Council (NHMRC) Fellowship. I have since become aware that, while holding NHMRC Fellowships in the past, Professor Rodgers is not the current recipient of a Fellowship.

I also intend to make minor revisions to page 2 of the Government Response (footnote 2 and the textbox).

The corrigendum to the Government Response is at Attachment A. I ask that it be made available on the Committee's website as a matter of priority.

## **Corrigendum to the Government Response to the Standing Committee on Public Accounts Inquiry: Report 18 into Elements Impacting on the Future of the ACT Clubs Sector**

### Footnote 2

This corrigendum omits the following words from Footnote 2:

“The lessee must then pay out the lease to the Territory for its current market value. This payout amount is calculated in accordance with section 263 of the *Planning and Development Act 2007*.”

And, to provide a more fulsome explanation of deconcessionalisation, replaces with the following:

“The lessee must then pay to the Territory a sum of money to pay out the concession. The payout amount is calculated in accordance with Section 263 of the *Planning and Development Act 2007* and is based upon the market value of the lease with the existing purpose clause.”

### Textbox on page 2

This corrigendum omits the following words from the Textbox on page 2:

“any club lease is “possibly a concessional” lease”

And, to ensure consistency with legislative terminology, replaces with the following:

“any club lease is a “possibly concessional” lease”

### Recommendation 22

Recommendation 22 of the Government Response states that the current Director of the ANU Centre is the recipient of a National Health and Medical Research Council Fellowship.

This corrigendum omits the following words from the Government’s Response to Recommendation 22:

“and the current Director is the recipient of a National Health and Medical Research Council Fellowship.”
