

**Government Response to the Standing Committee on  
Education, Employment and Youth Affairs on the  
Cessation of the Music for Colleges Course Report 7**

## Executive Summary

Music is an important part of the cultural fabric of the ACT and ACT schools play an important role providing the appropriate opportunities for students to engage with music and to support and nurture aspiring musicians.

The Australian National University (ANU) has historically offered music extension courses for students in years 11 and 12 to support talented musicians in ACT schools. The ACT government commenced discussions with the ANU on the new Community Outreach Program in December 2016 to manage the transition away from previous music programs. The decision to transition government arts funding away from Music for Colleges by the end of 2019 was announced in February 2018 by the Minister for the Arts, Creative Industries and Cultural Events. It is important to note that the historic funding for the Music for Colleges program for music development and community access (through artsACT) was distinct from the funding for the totality of H Courses (through the Education Directorate) for programs in a range of subjects focused on individual student extension. Separate funding agreements and governance arrangements were in place with the ANU. The ANU subsequently advised that it was no longer able to offer the H course in Music.

The ACT Government has been consistent in its position that the ANU receives funding from multiple sources and the decision on the allocation of funding to programs and therefore the cessation of any offering, has been a decision of the university.

The Government notes the important role the ANU School of Music has provided over many years and appreciates that the Music H Course was highly valued by students, teachers and parents for the high calibre tuition it provided and the opportunities it afforded. The Government also notes that the Music H Course only benefits a very small proportion of the senior secondary cohort, including those from the Catholic and Independent school sectors.

The ANU has confirmed that the course could not be delivered without an additional \$230,000 funding and on this basis the Government does not agree to recommendations 1, 2 4 and 6, and instead agrees to the dissenting recommendation provided by Mr Pettersson MLA.

The Education Directorate has designed an alternative offering that will ensure music extension opportunities for talented music students in the public education system, by strengthening the existing music program in ACT public schools. This will be facilitated by:

- continuing to offer high quality music programs within Colleges;
- further develop music education pathways with the Canberra Institute of Technology;
- the Instrumental Music Program which will allow students to have performance and practice opportunities through ensemble and auditions; and
- engaging specialist instructors to provide sessional instruction, augmenting existing music programs and the Instrumental Music Program. This is subject to cost and may be a means-tested support to enhance equity while supporting financial viability

The Government would like to thank the Committee for conducting this Inquiry and would also like to thank the members of the public who took the time to make a submission and to give evidence at the public hearings. Their concern and commitment to music education is commendable.
