In relation to:

THE CHAIR: The last annual report, you reported that six paths from the community path priority list had been built in Belconnen. And five of those paths are the College Street in Bruce, Western Verge of Coulter Driver in Page, two locations along Johnston Smith Drive in Belconnen, off Stockdale Street in London—Lawson, sorry. And off Luxton Street in Belconnen.

So, I am just wondering, just in terms of an update, have those paths been filled and completed?

MR CHAIR: Mr Smith.

Mr Smith: Jeremy Smith, Executive Branch Manager, Infrastructure Delivery. I have read and acknowledge the privilege statements. Thanks for the question.

In relation to those paths, I am of the understanding that the majority of those, if not all of them, have been built, but I would need to take the question on notice to be able to provide a full and frank answer.
