ACCOMPANYING STATEMENT

Background

Section 10 of the *Remuneration Tribunal Act 1995* (the Act) provides for the Remuneration Tribunal (the Tribunal) to inquire into and determine the remuneration, allowances and other entitlements to be paid to a person holding a position or appointment mentioned in schedule 1 of the Act, or any other position or appointment referred to the Tribunal by the Chief Minister.

On 13 December 2024, the Chief Minister requested the Tribunal to determine the remuneration, allowances and other entitlements for the Chair, Machinery of Government Taskforce.

Considerations

The Tribunal noted that the Chair, Machinery of Government Taskforce is a non-statutory role appointed by Cabinet, established to conduct and lead a review of the structure and capability of the entities undergoing machinery of government changes.

In considering the remuneration of the Chair, Machinery of Government Taskforce, the Tribunal has considered the breadth and impact of the role, the leadership required, and the remuneration applicable to past similar appointments by the ACT Government.

Decision

The Tribunal determined the Chair, Machinery of Government Taskforce will be remunerated at a level equivalent to the remuneration package of a public service Executive Level 4.2 in accordance with the relevant determination of the Australian Capital Territory Remuneration Tribunal from time to time.
