MINISTER CORBELL: The answer to the Member's question is as follows:—

- 1. The leasing of commercial roof space is not an ACT government program. It is a private contractual arrangement between landlords and renewable energy generators.
- 2. The generator would be eligible for the payment of the Feed-in tariff Premium Price appropriate to its scale. While the micro component of the scheme was officially closed on 31 May 2011, provisions exist for late applications from parties who had already signed contracts and/or paid deposits.

a. That is:

Installations up to 30 kW (Micro Generator) – 45.7 cents Installations larger than 30kW but no more than 200kW (Medium Generator) – 75% of the Premium Rate (34.27 cents)

c. All installations will count towards the cap of their respective Scheme component.

 - b. Why did the Government use a different accounting methodology, and where did it get this from?
 - a. Please provide details on the specific elements of the ACT Government's methodology?

MINISTER CORBELL: The answer to the Member's question is as follows:

1.

- a. The ACT has taken the policy view of taking responsibility for the creation of greenhouse gas emissions related to energy consumed in the ACT.
- b. The ACT Government commissions an ACT specific greenhouse gas inventory separate to the State and Territory Greenhouse Gas Accounts prepared by the DCCEE as the National Accounts provide only a partial inventory of emissions for the ACT. They do not include emissions from electricity at the point of consumption and represent ACT transport emissions simply as a fraction of NSW data.
- c. The methodology for the ACT Greenhouse Gas Inventory is included in the 2007/08 report. This report is available on line.

1. The Environment Protection Authority (EPA) continues to work closely with stakeholders, environmental consultants and independent auditors at these sites to ensure the sites are being managed in accordance with the statutory requirements under the Environment Protection Act 1997 and national guidance as detailed in the EPA's Contaminated Sites Environment Protection Policy 2009 (CSEPP). http://www.environment.act.gov.au/ data/assets/pdf_file/0007/198529/Contaminated_sites_WEB_dec09.pdf

In April 2011 the EPA issued approval for the recommencement of transport and disposal of geotechnical unsuitable material (including soil) impacted by asbestos from the North Weston Pond Site to the borrow pit at the former West Belconnen landfill site.

To facilitate a more sustainable outcome (and following the pond redesign) the EPA has supported the reuse of some low risk asbestos impacted material in the construction of the sub liner and embankment sections of the North Weston pond. This support is subject to strict environmental management conditions and the contaminated land auditor's endorsement as well as the endorsment of the land custodian (TaMS).

With regard to the Eastlake site the EPA received and reviewed the independent Auditor's draft site audit statement and report into the adequacy of the remedial action plan in late April 2011 and has subsequently also reviewed the remedial action plan (RAP) for the site. The EPA is working with independent primary stakeholder, and the auditor to ensure best practice and sustainable management of the contamination issues within the Eastlake development.

Prior to these sites being reused for other purposes the independent auditor's site audit statements into the suitability of the sites for their intended uses must be reviewed and endorsed by the EPA.

- a. The EPA has provided advice to the Government that the sites must be assessed, remediated and independently audited in accordance with the EPA's CSEPP and the ACT Government Strategic Plan Contaminated Sites Management, 1995 prior to a change in landuse. The findings of the audits must be reviewed and endorsed by the EPA prior to the sites being used for other purposes.
- b. The most recent data analysis of the EPA's Contaminated Sites Management Database and Geographic Information System shows a total of 892 sites. These sites fall into the following categories:

Hydrocarbon sites – 473

Landfill sites - 116

Other sites - 151

Sheep dip sites -152

Sites included in the above are known contaminated sites and potentially contaminated sites. Operational service stations, landfills and industrial activities are recorded as potentially contaminated, other sites such as remediated sheep dips or redeveloped service stations are recorded as known sites that have been cleaned up or are subject to a management plan.

The process established by government to provide advice on known and potentially contaminated sites is outlined in the EPA's CSEPP. Information is supplied to the community through a Contaminated Land Search, similar to

the approach in other jurisdictions. The list is not broadly available due to privacy and confidentiality considerations as most sites are on leased land. However, information can be provided about specific sites if a search is requested by a member of the public (charges apply).

- c. As these sites are redeveloped the EPA requires that they are assessed, remediated, if required, and audited to ensure that they do not pose a risk to human health or the environment and are suitable for their permitted uses from a contamination perspective. The results of any assessment must be reviewed and endorsed by the EPA prior to the sites being used for other purposes.
- 2. There are fees for companies applying for an Environmental Agreement.
 - a. The term of an Agreement is three years from the date of signing and covers all sites developed by the Agreement holder. The EPA holds 98 current Agreements for land development.

The conditions in an Agreement detail the measures required to minimise impacts on our waterways. These measures include staging of works, the provision of sediment retention dams, stabilised access points and silt, erosion and diversion controls. The Agreement holder is required to submit a sediment and erosion control plan to the EPA for approval outlining these measures prior to works commencing. There are also conditions which require the measures to be maintained throughout the life of the development.

SIMON CORBELL MLA: The answer to the Member's question is as follows:

- (1) Domestic Animal Services (DAS) reduced the shelter opening hours to the public in March 2010. This measure allows Rangers to spend more time proactively patrolling the urban areas, in particular parks and reserves. The Territory and Municipal Services Directorate (TMSD) recently created a new part-time position of Kennel Master. This measure will also allow experienced Rangers more time away from the shelter to enforce the provisions of *the Domestic Animals Act 2000*. The existing DAS budget has been supplemented to allow for the creation of the Kennel Master role. There are no additional funds available to DAS in the 2011-2012 budget.
- (2) Public safety complaints include reports of overhanging foliage, obstructions caused by signs or long grass and abandoned motor vehicles. These complaints are investigated by City Rangers. Obstructions are either rectified at the time of attendance or relevant notices are issued for compliance within the legislated time frames. Where a notice is issued, City Rangers re-attend to ensure compliance. City Rangers respond to complaints of public safety issues within two days. Where a public report is received

- (1) What programs and projects will the additional support enable the RSPCA to run and what accountability does this additional funding required of the RSPCA?

SIMON CORBELL MLA: The answer to the Member's question is as follows:-

- 1. The Government is presently negotiating a two year Service Funding Agreement (SFA) with the RSPCA. The SFA outlines the services the RSPCA provides on behalf of the Government. These include three key areas of animal welfare:
 - (i) the provision of an animal shelter and the reception of stray and/or abandoned animals;
 - (ii) the provision of an animal welfare inspectorate to investigate animal welfare offences; and
 - (iii) the provision of a native animal care and rehabilitation for release program. The RSPCA will be required to provide the Government with regular reports detailing the activities undertaken under the three broad categories in the SFA.
- 2. The value of the SFA for 2011-12 is \$570,000, an additional \$150,000 from the previous financial year. Funding for the RSPCA beyond 2011–2012 will be the subject of further negotiation and the decision within the normal budget processes.

- (1) What is the progress of the development of animal welfare mandatory codes of practice and how are these integrating with the national approach?
- (2) When will all relevant mandatory codes of practice be completed?
- (3) What formal and informal relationships does the government animal shelter have with the RSPCA in relation to the management of abandoned, lost and surrendered domestic animals?
- (4) Over recent years, what has been the trend in numbers of domestic animals coming into and being dealt with in the animal shelter and to what extent is the facility coping with those trends?
- (5) Typically, what is the nature of animal welfare investigations undertaken by the directorate and what is the average time taken to complete these investigations?

SIMON CORBELL MLA: The answer to the Member's question is as follows:-

(1) The Animal Welfare Advisory Committee (AWAC) develops and recommends codes of practice under the *Animal Welfare Act 1992*. AWAC is well advanced with a review of the 'Code of Practice for the Sale of Animals (other than from sale yards)' which is the first code including mandatory standards to be reviewed by AWAC. This draft code is expected to be available for public/stakeholder consultation by the end of July 2011.

All current animal welfare codes of practice now provide for the inclusion of mandatory enforceable standards and AWAC's forward work plan includes the review of codes covering injured wildlife, pounds/shelters, dogs and cats. Further codes will be identified for review after the completion of the current work plan. Review of the codes of practice is an ongoing and continuous process.

The Australian Animal Welfare Strategy predominantly concentrates on livestock, transport and issues of national importance. There has been no overlap of code subject matter to date. National codes are also ratified by AWAC.

- (2) See answer to Question (1) above. Review of the codes of practice is an ongoing and continuous process.
- (3) Informally, dogs are transferred between both Domestic Animal Services and RSPCA facilities on an 'as needs' basis. All puppies and cats that are either handed into the DAS shelter or come into the care of Rangers are transferred to the RSPCA. Under a formal arrangement, de-sexing vouchers, which are redeemable at the RSPCA, are also sold at DAS to owners collecting their dogs from the shelter; and dogs surrendered to the RSPCA are C3 vaccinated before they are transferred to DAS and all other dogs entering the DAS facility are C3 vaccinated as a disease control initiative.
- (4) In the last three years the number of dogs impounded at the DAS facility has fallen annually by approximately 350 dogs. As a result, the facility is able to meet current demands.
- (5) Animal welfare investigations are conducted on behalf of the ACT Government by the RSPCA-ACT. Inspectors' corrective action ranges from prosecution through the courts to information and training provided to pet owners in the appropriate care of their animals. The length of investigations varies from a few hours in the case of minor matters, to some months in the case of complex investigations which are referred to the Magistrate's court for determination.

Simon Corbell: The answer to the Members question is as follows:

1) Community briefings and consultations since the project inception in February 2011, have been provided to environmental and recreation groups; to the Molonglo Community and Industry Reference Group – CIRG (March, May 2011); and to a Conservation Council Forum in May 2011. Additionally, the project was included in the Molonglo Community Forums held in March and May 2011. A detailed presentation of the draft concept plan is scheduled for 8 June 2011, with stakeholder responses invited. Further detailed consultation will be required in the future as part of the statutory process to prepare a Plan of Management.

The project consultancy team consists of well-credentialed experts in landscape, environment, fire management and recreation planning.

- 2) Project terms of reference (objectives):
 - To prepare an illustrated River Park Concept Plan (RPCP) for the Molonglo River; and
 - The concept plan will provide a strategy for the reconciliation of conflicts between protection of environmental values, bushfire mitigation and impacts from recreation and adjoining development.

3) Preparation of the River Park Concept Plan commenced in February 2011 and the Final Report for Government consideration is due August/September 2011.

- (1) During 2010-2011 the TAMS Directorate (TAMSD) has undertaken community education programs including:
 - Wide public and retail sector consultation on the implementation of the *Litter* (Shopping Trolley) Amendment Act 2010.
 - Domestic Animal Services (DAS) undertook a series of community notifications detailing the new requirements to have both dogs and cats micro-chipped.
 - DAS conducted three free or discounted micro-chipping days for pet owners at their facility which were promoted in the media to raise greater awareness of the new requirement to have cats and dogs micro-chipped. TAMSD also provided all Canberra veterinarians with a poster detailing the new requirement.
 - A DVD on the requirements of responsible dog and cat ownership has been produced and provided free of charge to Rescue Services, Pet shops, Dog Clubs and persons purchasing a dog from DAS.
 - TAMS staff within the native animal and plant licensing section regularly participate in user group activities and meetings.

- City Rangers and DAS Rangers participated in community days organised by the Australian Federal Police (ACT Policing) at various locations across the ACT where they have provided advice to the community on a range of regulatory and compliance based issues.

SIMON CORBELL MLA: The answer to the Member's question is as follows:-

- (1) All the high priority environmental weeds (blackberry, African lovegrass and serrated tussock) and pest animal species (rabbits, foxes and feral pigs) that are managed in the ACT are widespread in south eastern Australia and, therefore, impossible to eradicate. Re-infestation is an on-going process on both public and private land and controlling these pest species is the only option available.
- (2) The techniques used to assess the effectiveness of pest animal management programs depend on the particular pest animal. They include spotlight counts for rabbits, sand pad monitoring for foxes, records of attacks on livestock for wild dogs, and monitoring plots for feral pig ripping.

The cover or abundance of environmental weeds in an area is measured according to categories developed by the Bureau of Rural Sciences for measuring the cover of Weeds of National Significance. Photo monitoring points and mapping using these categories is used to assess whether progress in reducing weed cover is being made.

Ms Gallagher: The answer to the Member's question is as follows:—

- 1. The funding allocated to OHS harmonisation will be used to fund salaries and other costs of the ACT's participation in national fora completing the harmonisation process. Whilst it is expected that all jurisdictions will enact laws to give effect to the model Bill and Regulations by 1 January 2012, it is anticipated that work on harmonisation will continue throughout 2012. An evaluation of the requirements for future work will be undertaken in early 2012.
- 2. The harmonisation process is built around an Intergovernmental Agreement, overseen by the Workplace Relations Ministers Council. Under the Agreement, the Government is committed to mirroring the model Work Health and Safety Act, subject to our drafting protocols. The ACT Work Health and Safety Bill when enacted will see only minor changes from what exists in the *Work Safety Act 2008*, including:
 - a. The loss of crown immunity;
 - b. The reduction of the maximum period of imprisonment from 7 years to 5 years; and

c. The replacement of the statutory right for third-parties to bring prosecutions with a right for third parties to seek review by the Director of Public Prosecutions of decisions by the regulator not to prosecute.

1. From 1 July 2010 until 30 April 2011 WorkSafe ACT has conducted 2,006 workplace safety visits. Below is a summary of the safety visits and the outcomes of the visits.

- 2. In the financial year 2010/2011, WorkSafe ACT have performed 30 investigations into workplace bullying, resulting in three Improvement Notices being issued. The Improvement Notices relate to:
 - i. failure to provide information, instruction, training & supervision to employees.
 - ii. provide a safe working environment without risks to health.
 - iii. have systems in place to consult with employees

Of the 30 complaints about workplace bullying:

- 17 are still under investigation;
- 7 were found not to be bullying;
- 1 was resolved; and
- 5 were withdrawn or no further action was required.

- 3. WorkSafe ACT has procedures for investigating workplace bullying in line with its published Work Safety (Preventing and Responding to Bullying at Work) Code of Practice 2010. These procedures were updated in 2011 and all inspectors currently involved with bullying cases have received appropriate training.
- 4. All complaints received by WorkSafe ACT are considered and responded to, but not all complaints require investigation. WorkSafe ACT complaints are prioritised through consideration of:
 - The severity of the injury or dangerous occurrence.
 - Control measures implemented at the workplace.
 - The non-compliance history of the workplace.
 - The risk profile of the particular industry that the complaint relates to.
- 5. WorkSafe ACT responds to every complaint within three business days.
- 6. All bullying complaints to WorkSafe ACT in 2010/2011 have been responded to.
- 7. The program is an education and awareness program. The program includes a series of pamphlets outlining what bullying is, how bullying can be removed from the workplace, information on the complaints resolutions process and training modules to prevent bullying. Over 2000 workers have received training under the program this year to date in relation to understanding and/or preventing bullying.
- 8. There are a number of laws in the ACT that may apply to workplace bullying. These include:
 - Work Safety Act 2008;
 - Discrimination Act 1991;
 - Public Sector Management Act 1994;
 - Domestic Violence and Protection Orders Act 2008;
 - Workers Compensation Act 1951;
 - *Crimes Act 1900 (ACT);*
 - Crimes Act 1914 (Commonwealth); and
 - Safety, Rehabilitation and Compensation Act 1988.

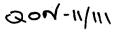
Yes, the powers of WorkSafe ACT extend beyond issuing an improvement notice to an employer. Both employers and / or workers can be prosecuted for failure to comply with their safety duties under the *Work Safety Act 2008*.

9. The Government is of the view that existing laws adequately address situations of bullying and harassment in the workplace. The Government will however keep this matter under review.

The drop in staff numbers is due to two main factors: (1) an expected reduction in casual staffing requirements due to a lower volume of theatre business; and (2) an expected reduction in staffing, primarily casual staffing, as part of the Corporation's 2011-12 budget strategy to address the whole-of-government efficiency dividend and savings initiative.
- 2. Due to the variability of the Corporation's staffing as a result of employing a large number of casual staff, it is not possible to identify precise roles and pay grades of these staff. They would be expected to be from areas such as: Canberra Theatre Centre front-of-house, ticketing and technical staff; and museum assistants at the Canberra Museum and Gallery and at ACT Historic Places.
- 3. The breakdown of revenue collected for 2010-11 is expected to be as follows, noting that revenues collected centrally have been split across these three areas:

a) The Canberra Theatre Centre:

\$4,652,463 or 81.3 % of total revenue

b) The Canberra Museum and Gallery:

\$773,940 or 13.5 % of total revenue

c) The ACT Historic Places:

\$299,090 or 5.2% of total revenue

While it is not possible to identify the precise revenue that will be collected in future years for these three areas, it is expected that the breakdown of revenue collected will be of a similar pattern to that identified above.

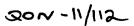

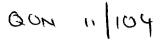

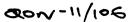

Minister Burch: The answer to the Member's question is as follows:-

Response

- 1) The current Centenary of Canberra budget has been committed to support a broad range of celebratory projects. As a key speaker at the CSO partner's lunch in September 2009 the Chief Minister announced that an Australian composer would be commissioned to write a symphony about Canberra which will be performed by the CSO in 2013 as part of the Centenary of Canberra celebrations. An allocation was then made in the 2010-11 Budget for the Symphony.
- 2) Centenary of Canberra creative director Ms Robyn Archer AO has liaised with representatives from CSO who are fully supportive of this initiative.
- 3) The Centenary of Canberra program of celebration is currently being shaped to offer a range of projects, events and activities that are celebratory, creative, have ingenuity and importantly provide a range of lasting legacies. The commissioning of a symphony meets each of these requirements. The Symphony will be presented in a large scale outdoor setting, following the recent success of concerts by the CSO in Commonwealth Park. By commissioning a major composer, it is anticipated the works will be presented by other orchestras nationally and internationally beyond 2013.

The Canberra Social Plan Progress Report 2009 identifies a priority to enhance community access to, and participation in, the arts and other cultural activities and the

commissioning of a Symphony for inclusion within the 2013 program of celebrations provides an opportunity for Canberrans to engage in a first class cultural performance celebrating and commemorating their city.

- 4) A preferred composer has been identified however negotiations to confirm the appointment are still being negotiated between the Centenary and Canberra Symphony Orchestra. The Creative Director Ms Robyn Archer AO is leading the process to commission an Australian composer of the highest standard.
- 5) It is anticipated the composer will be engaged during late 2010. Adequate time is required for the chosen composer to write the music and for the CSO to rehearse in the lead up to the premiere event in 2013.
- 6) It is anticipated the symphony will be performed during a large scale community event in 2013. The exact date and location are yet to be confirmed.
- 7) The performance will be free for the public to attend.

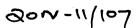

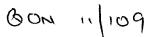

- (7) What consideration has the government given to making the facility available for music and the performing arts? If none, why?
- (8) What were the key driving elements that led the government to decide that the facility should be given over for a print studio and workshop? Did those key driving elements consider the alternative use of the facility as a music and performing arts facility? If no, why?

Minister Burch: The answer to the Member's question is as follows:-

(1) The ACT Government's Arts Facilities Strategy, developed in 2003, outlines the Kingston Foreshore as "leading visual arts production and activity". Although it has been intended since 2003 that the Kingston Arts Precinct should have a visual arts focus, other complementary arts and cultural activities will also be incorporated into the Precinct. Music and performing arts will part of the diverse activity at the Kingston Arts Precinct.

(2) The Territory has intended since 2003 that the Kingston Arts Precinct should have a visual arts focus and therefore that the Fitters Workshop would have a visual arts occupant. Consultation was conducted as part of the ACT Government's *Arts Facilities Strategy*, developed in 2003 and most recently artsACT engaged Ms Susan Conroy, Cultural Planner, in October 2010 to develop the *Kingston Arts Precinct Strategy*. The aim of this consultancy was to develop a high-level consolidated and comprehensive Kingston Arts Precinct Strategy, to inform the future development of the Kingston Foreshore.

The project team worked closely with artsACT, as well as other ACT Government agencies, to develop the Kingston Arts Precinct Strategy. A number of key stakeholders, including those from the visual arts sector and the arts sector more broadly including representatives of the performing arts sector, were consulted during the development of the Kingston Arts Precinct Strategy.

- (3) The Government has taken expert architectural, Heritage and structural and hydraulic engineering input in relation to the future use of the Fitters Workshop for visual arts purposes as part of the building fit-out requirements of Megalo.
- (4) Specialist acoustic advice on the Fitters Workshop has not been sought as is not required for occupation by visual arts organisation, Megalo.
- (5) Alternative locations for a print workshop at the Kingston Foreshore have not been considered. The Territory has intended since 2003 that the Kingston Arts Precinct should have a visual arts focus and that the Fitters Workshop would have a visual arts occupant.
- (6) A number of representations have been made to government by patrons of the music community and government has advised the sector of the decision taken in 2003 to have a visual arts focus at the Kingston Arts Precinct. Other performance opportunities will be provided at the Kingston Arts Precinct in a range of locations both internal and external. Government has recently spent considerable monies upgrading the Albert Hall as a performance venue.
- (7) No consideration has been given to making the facility available for music and the performing arts as the Fitters Workshop will be occupied by the print making organisation, Megalo.
- (8) The key driving elements that led the government to decide that the facility should be given over for a print studio and workshop were the findings of the ACT Government's *Arts Facilities Strategy*, developed in 2003, that identified the Kingston Foreshore as, "leading visual arts production and activity".

The alternative use of the Fitters Workshop as a music and performing arts facility has not been considered by government however, the *Kingston Arts Precinct Strategy* (2010) documented widespread support for a broad expression of visual arts represented in the Precinct that would include film, video, performance arts, installations, special events, community events and cultural festivals. There will be opportunity for the expression of more diverse artforms across the broader Kingston Arts Precinct.

- 2) CPI of 2% to 2.5% CPI is used for key arts organisations.
- 3) Key arts organisations Deeds of Grant include flexibility in programming and budgeting for each year of the Deed to meet changes and challenges.
- 4) Canberra Arts Marketing Inc received \$115,000 from the ACT Arts Fund in 2008.

- 5) No specifically funded programs, however through the Australian Business and the Arts Foundation, AbaF, a number of fully subscribed workshops have been presented in the area of marketing, promotion and networking.
- 6) These programs have been presented free of charge or at subsidised rates through AbaF.
- 7) Significant positive feedback has been received through participant comments.

(5a)The terms of reference for the ACT Public Art Panel for its most recent period of operation from July 2009 – June 2010 were:

- 1. The ACT Public Art Panel will provide direct advice to the Minister, through artsACT, on matters relevant to public art in the ACT. For the term of its appointment the Panel will provide recommendations on a program of acquisitions and commissions under allocations to the Public Art Program. The Panel will make recommendations on:
 - appropriate acquisition methods for new works of public art, which may include direct acquisition, select tendering and direct commissioning of works (with the advice of Procurement Solutions as necessary);
 - specific artworks for purchase;
 - the commissioning of particular artists for specific projects;
 - consultation with stakeholders, including local community representatives, for specific projects;
 - the siting of artworks;

- 4. Specific recommendations on artwork acquisitions and commissions utilising the bulk of available funds will be presented to the Minister by 31 October 2010. A review of progress with the Minister will be scheduled during January/February 2010.
- 5. Indicative sites for new works of public art include but are not limited to:

- Major commissions or acquisitions (5 to 6 works up to \$2.4 million)
 - o Drakeford Drive, Tuggeranong (1 work)
 - o Belconnen Way, Belconnen (1 work)
 - Morsehead Drive/Piallago Ave (probably 2 works). Panel to provide view on sites identified or alternative sites if preferred
 - Federal Highway nr to Dickson/Yowani (1 work), or alternative sites if preferred
 - O Possible site on Parkes Way nr Civic / Commonwealth Park (1 work)

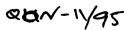

- (1) The Corporation is developing a comprehensive budget strategy for 2011-12 to achieve sound and sustainable finances and meet the whole-of-government efficiency dividend and savings initiative requirements. It is expected that the strategy will include both revenue-raising measures, such as pursuing opportunities for additional theatre venue hire business, and cost saving measures, such as reducing the cost of IT services, electricity, rent, training and consultancies, and reducing opening hours at the Canberra Museum and Gallery and the ACT Historic Places, focusing on reducing times of lowest visitation.
- (2) The Corporation adopts a number of strategies to address the impact of increased cost of living on patronage of its activities, including through the provision of free events such as the popular family program *CMAG* on *Sunday*. In terms of activities in its performance venues, the Corporation: provides certain activities at no cost or a gold coin donation, such as *Music at Midday* concerts and pre-show patron forums; seeks sponsorship for certain activities in order to contain the cost to patrons; operates a Social Capital program, whereby tickets are provided on a complimentary basis, through targeted community organisations, to those who would not otherwise have the opportunity to attend live theatre; and keeps the ticket prices for theatre shows that it presents at a competitive rate. It should be noted, however, that most theatre shows at the Canberra Theatre Centre are presented by commercial hirers and the Corporation does not control the ticket prices charged for these shows.

(1) The ACT Older Persons Assembly Steering Committee was formed to progress development of the ACT Older Persons Assembly. It comprises eleven members and includes representatives of the ACT Ministerial Advisory Council on Ageing, Council on the Ageing (ACT), Combined Seniors Group of the ACT and Community Services Directorate. My advisor on ageing is also a member of this Committee.

Members of the Steering Committee are encouraged to represent their organisations and the broader community of older people in their role as Committee member. As such, it is expected that they will engage and consult with seniors organisations and other seniors during the planning of the Assembly.

Key seniors organisations have been informed about the Older Persons Assembly and have been encouraged to nominate members to participate.

(2) If more than seventy nominations are received, delegates of the ACT Older Persons Assembly will be selected by an assessment panel using the following criteria:

Eligibility criteria

- ACT resident
- Over 55 years

Prioritisation criteria

- Two-thirds of applicants must be individuals
- One-third of applicants will be organisational representatives

The selection panel will use relevant population statistics to ensure that a representative sample of the 55+ population is selected from:

- each Canberra District;
- each gender group;
- each age sub-group;
- the culturally and linguistically diverse community;
- the Aboriginal and Torres Strait Islander community;
- various socio-economic groups; and
- identified areas of specific interest.

The composition of the Selection Panel will include as a minimum representatives from ACT Older Persons Assembly Steering Committee and Community Services Directorate.

- (2) The title of the Strategic Plan is Towards an Age Friendly City. What action is the ACT Government undertaking to achieve this?
- (3) The seven identified strategic priorities of the Strategic Plan are: Information & Communication; Health and Wellbeing; Respect, Valuing and Safety; Housing and Accommodation; Support Services; Transport and Mobility; Work and Retirement. What work is the Government doing in each of these areas, including any funded programs or projects, and how you are progressing each of these priorities?
- (4) The Strategic Plan includes a modified WHO Checklist for Essential Features of Agefriendly Cities and an Implementation Plan for the first 18 months to June 2011. What progress is the Government making on implementing this checklist and the implementation plan?

Minister Burch: The answer to the Member's question is as follows:-

(1) The ACT Strategic Plan for Positive Ageing 2010-2014: Towards an Age-Friendly City was launched on 15 December 2009. The Plan was developed by the ACT Government with extensive community consultation and in partnership with the Ministerial Advisory Council on Ageing. It aims to provide a blueprint for a coordinated approach across Government and the community to support positive ageing and an age-friendly city where older people are respected, valued and supported to be active participants in their community. It was not a Plan with an allocated Budget, but rather, it sought to focus current Government resources on priorities identified by the seniors community.

The 2011-2012 Budget included many initiatives that address the goals of the Strategic Plan.

The goal of Strategic Priority Two of the Plan is that 'people in the ACT maintain their health and wellbeing across their lifespan to allow them to age positively and to actively Page 1 of 4

participate in their community as they get older'. The Budget delivered additional funding of \$4.2 million to meet the growing demands for health services by older Canberrans; and \$4.2 million to deliver improved and expanded health services for cancer suffers, which is especially relevant to older citizens.

The goal of Strategic Priority Four is that 'ACT seniors access appropriate and affordable housing'. In the Budget, the Government delivered a \$111.4 million boost over four years for land release and housing affordability, including the release of 2,400 dwelling sites dedicated to affordable homes. To assist low income households meet the household utility costs, the Budget delivered \$4.4 million over four years to expand the water and energy efficiency Outreach Program; \$8 million over four years to increase the energy efficiency of public housing dwellings; and \$12 million over four years to increase the utility concessions available to low-income households. The latter item means that eligible households can now access up to an additional \$131 a year in utility concessions.

The goal of Strategic Priority Six is that 'seniors easily move around in their community through personal, community and public transport, and walkways'. The Budget allocated \$2.3 million over four years to expand the Taxi Subsidy Scheme, with a 32% increase in the maximum discount people can get on taxi fares. The Budget also allocated over \$2 million over four years to enhance the promotion and marketing of ACTION bus services including information on accessibility. Given the traditional reliance of Canberrans on private cars, it is particularly important that older Canberrans are encouraged and supported to start using ACTION buses. Other relevant Budget initiatives include the upgrade of the Eastern Valley Way public area, which will see the installation of a pedestrian bridge, public toilets, street furniture, shade and lighting – all of which are essential if we are to encourage older citizens to walk around their suburbs.

The goal of Strategic Priority Seven includes the goal that retired people will continue to actively participate in our community through recreational activities. The Budget has allocated \$32.3 million to improve sport and recreational opportunities for Canberrans, including seniors. For example, the \$2.1 million allocation for the development of a multi-use community facility at Greenway will include a separate area for the Tuggeranong Men's Shed.

(2) and (3)

The Government is working towards an Age-Friendly City through the current Implementation Plan of the five-year Strategic Plan for Positive Ageing.

Later this year, the ACT Ministerial Advisory Council on Ageing will be providing me, as the Minister for Ageing, with a Report on the Implementation Plan up to 30 June 2011. Progress has been reported in the 2009-2010 Annual Reports of ACT Government Agencies.

In terms of 'Information and Communication', progress to date has included the launch of the ACT 'Seniors Information Online' portal at seniors.act.gov.au, and the Woden Library's provision of three training sessions per week targeted specifically at seniors.

Regarding 'Health and Wellbeing' actions, on 2 June 2011, the Minister for Health, Katy Gallagher MLA, officially launched the GP Aged Day Service, which provides General Practitioner locum support to those who are homebound or in residential aged care, when their regular GP is unable to make a house call. The service aims to support ACT GPs and the aged community and their families, by providing care to frail or aged patients who need prompt attention and might otherwise been admitted to hospital. Funded by the ACT Government and implemented by the ACT Division of General Practice, the GP

Aged Day Service is part of the \$12 million GP workforce package which was provided under the 2009-10 ACT Budget.

To promote the wellbeing of seniors, 13 projects were approved in the 2010-11 Seniors Grants Round which promoted the social inclusion of seniors, for example, the Red Cross Telechat program for isolated seniors, and the 'Old Stories, Young Eyes' program which promotes intergenerational work by bringing school children into aged care homes.

Regarding 'Respect, Valuing and Safety', the Government continues to promote positive images of seniors through the Life's Reflections Photographic Competition and Exhibition and the Canberra Gold Awards. In March 2011, the Elder Abuse Prevention Program was strengthened when Anglicare took on the administration of the Abuse Prevention Referral and Information Line.

Under 'Housing and Accommodation', the Government is nearing completion of 297 units for older persons on eight sites across Canberra.

In providing 'Support Services' the Government has increased the concessions available to eligible seniors for essential services.

In supporting 'Transport and Mobility' the Government estimates that 44.6% of the ACTION fleet will be wheelchair accessible by 30 June 2011. Over this financial year, 30 bus shelters and 392 seats were installed, making public transport more accessible for seniors. The Government has also increased the Taxi Subsidy Scheme concession rates by 32%. In relation to the planned evaluation of the Regional Community Bus Service, Territory and Municipal Services has completed a preliminary survey of current operations as part of the Coverage Services Delivery Study which is expected to be finalised this month.

For 'Work and Retirement' a 'Business Guide to Seniors as Employees and Customers' is expected to be finalised over the next two months, and the Government has supported retirement planning programs through the Seniors Grants Program.

(4) In 2010, Canberra was accepted into the WHO Global Network of Age-Friendly Cities. This membership involves a commitment to continuous improvement of the age-friendliness of the city. The WHO defines an Age-Friendly City as 'an inclusive and accessible urban environment that promotes active ageing'.

In March this year, the Community Services Directorate established the Canberra Age-Friendly City Network, with Government and community members, to serve as a reporting channel and a forum in which ideas could be shared and promoted.

This Network will assist the Community Services Directorate to develop the 2012-2014 Action Plan, which will also be informed by an Age-Friendly City Survey in July this year and the Older Persons Assembly in September.

Regarding the Survey, while the Government undertook extensive consultation in 2009 to establish local priorities, this Survey will establish a more systematic baseline assessment of Canberra through the lens of the WHO Checklist of Essential Features of an Age-Friendly City.

Minister Burch: The answer to the Member's question is as follows:-

- (1) The ACT Elder Abuse Prevention Policy was developed and released in April 2010 in accordance with the recommendations of a Strategic Review (January 2009). The policy will be reviewed in 2012.
 - Ongoing development of the Elder Abuse Prevention Program is being guided by the Elder Abuse Prevention Network, which includes representatives from ACT Health, the Council on the Ageing (ACT), Carer's ACT, Alzheimer's Australia ACT, the Human Rights Commission, the Public Advocate of the ACT, the Public Trustee for the ACT, the ACT Ministerial Advisory Council on Ageing, relevant community organisations and a representative from the Aboriginal and Torres Strait Islander Community. The Network provides strategic advice on systemic issues relating to elder abuse, the coordination of services that support older people and guidance on program priorities. Further support in monitoring the effectiveness of the Program is provided by the ACT Ministerial Advisory Council on Ageing.
- (2) Between 1 October 2009 and 16 March 2011, the Office for Ageing took 132 calls on the Older Persons Abuse Prevention Referral and Information Line. The phone service was transferred to Anglicare Canberra & Goulburn in March 2011 following a procurement process. Between 17 March 2011 to 20 May 2011, Anglicare took 20 calls.

The Office for Ageing meets regularly with Anglicare Canberra and Goulburn to discuss the phone service and receives updates on phone line usage through quarterly reports. The phone line is meeting current demand for information and support on elder abuse.

SIMON CORBELL: The answers to the Member's questions are as follows:-

- 1. Yes.
 - a. I understand that the Brumbies have engaged a consultant to assist in the identification and assessment of possible training and administrative sites. Sport and Recreation Services have held discussions with these consultants as to the identification of a possible site and the criteria by which such sites would be assessed. It is understood that this work has yet to be finalised but will presumably be presented to the Brumbies Board upon completion for consideration of its content and any options for progression.
- 2.
- a. The following community consultations have been held:
 - The draft variation, associated background documents and a fact sheet were publicly available for 30 working days between Saturday 29 January and 15 March 2011;
 - Notice of the consultation was published in a daily newspaper, the Canberra Times Saturday 29 January 2011 and in the community notice board in the Canberra Times on Saturday 12 February 2011;

- Notice of the consultation was also placed on the ACTPLA web site along with a copy of the draft variation and supporting documents between 29 January 2011 and 15 March 2011. The draft variation was further notified on the ACT Government community engagement website from 11 February 2011 to 11 March 2011;
- A pamphlet was delivered to approximately 350 dwellings close the site by a private mail delivery service;
- ACTPLA staff also distributed flyers to businesses and shops in Griffith, and in Manuka in the blocks bounded by Furneaux St and Bougainville St, Flinders Way and Canberra Avenue; and
- Four A1 size posters were erected around the site on 9 February until late March 2011. The posters were located on the Austin and La Perouse St frontages and on the corner.
- b. In relation to DV307, there may be further consultation, if there is a Standing Committee inquiry prior to DV307 being tabled in the Legislative Assembly. Any such inquiry can include public submissions and hearings. However, this is a matter for the Standing Committee.

- 1. What additional resources will this initiative fund?

 - b. Why is it that revenue and expense figures are identical?
- 2. At present, how many Government energy rating auditors are there in ACTPLA?
 - a. How regularly do these auditors verify assessment reports?
 - b. What is the quality control process conducted by these Government auditors to ensure that rating assessments are accurate?
- 3. Of the approximately 200 assessors in the ACT, how many have received formal accreditation (full license) during the 12 month phase-in period, as per the Construction Occupation Legislation Amendment Bill 2010?
 - a. As part of ACTPLA's licensing requirements, are assessors required to have indemnity protection?
 - i. If yes, how much?
 - ii. If no, why not?
- 4. At present, what is the complaints process that is in place for home buyers and sellers who doubt the accuracy of the ratings assessments they've received for their house?
 - a. What information is available to the public should they wish to lodge a complaint?
 - b. Please outline the process in place should a member of the public wishes to lodge a request for a Government audit to assess the accuracy of their energy efficiency rating report.

- 5. Aside from the energy efficiency ratings assessments, what about structural and pest assessors?
 - a. Given that businesses provide a one-stop service for these assessments, what recourse for action do home-buyers and sellers have when unsatisfied with an assessment that's been provided?
 - b. Are there plans to bring these assessors to the same licensing standards as energy efficiency assessors?
 - i. If not, why not?

SIMON CORBELL: The answers to the Member's questions are as follows —

- 1. The additional resources funded by the proposal are the equivalent of 2.5 full time inspectors.
 - a. The revenue will be generated from licensing fees and lodgement fees for energy efficiency rating statements, certificates and associated documents.
 - b. The program is based on cost-recovery principles.
- 2. There is an equivalent of 2.5 inspectors to audit energy efficiency ratings as part of the auditing of new building approvals, sale of property assessments and respond to complaints.
 - a. The auditing function has only recently been established. There is a 5% audit target for all energy efficiency ratings.
 - b. There are a number of processes that are used depending on whether audits are proactive, the type of the assessment (e.g. for new building work) the complexity of the rating and whether the audit is part of an investigation. Audits range from checking software inputs align with building plans and specifications, to interrogation of the software file and on-site visits. The first year will also see an intensive education process for assessors and industry.
- 3. The phase-in period for registered assessors will not finish until 29 February 2012. At present 5 registered assessors have been granted a full licence. All other registered assessors remain as a deemed licensee under licensing legislation until the transitional period finishes.
 - a. Yes, as per the Construction Occupations Legislation Amendment Act 2010 assessors are required to hold professional indemnity insurance that provides indemnity against claims for breach of professional duty as a building assessor; and a minimum limit of indemnity of \$1,000,000 for a single claim. The license is automatically suspended if this insurance lapses.
- 4. The complaints process is that defined under the Construction Occupations (Licensing Act) 2004 (COLA).
 - a. The information on how to lodge a complaint is available on the ACTPLA website. Consumers can also contact customer services staff for further information on energy efficiency ratings, licensee obligations and the complaints process.
 - b. Energy ratings are conducted by private assessors. The Government does not provide audit on request service for energy ratings. The Government responds to complaints and enquiries about energy ratings as described above.

- a. The legislation requiring building and pest inspection reports is administered by the 5. Justice and Community Services Directorate (JACSD). Registration for both types of inspections is carried out by that Directorate. If vendors or purchasers are unsatisfied with the building inspection or pest inspection report or suspect non-compliance with the general disclosure requirements applying to residential sales or tenancies they can approach the JACSD.
 - b. Energy efficiency assessments are not only used for sale of property legislation but for compliance with building regulation. This is why both types of rating are regulated together under construction licensing. Individual businesses may choose to combine any number of services that are regulated by different areas of government. At present the Environment and Sustainable Development Directorate (ESDD) regulates only those occupations that are directly linked to construction legislation. Post-construction building and pest inspections are outside this and are regulated by JACSD.

MR CORBELL: The answer to the Member's question is as follows:

- 1. There will be a total of three additional officers.
- 2. There is no revenue collected for this project. It is a two year, targeted project.
- 3. Construction Services Branch currently has four building auditors and eight inspectors in an investigation team who deal with all complaints under land, planning and construction laws.
 - a. This information is available in the Annual Reports.
- 4. Information on complaint numbers is available in the Annual Reports.
 - a. It is common place for complainants to raise a series of issues in one complaint. Some of these can be actioned under the relevant planning and building legislation, some issues are deemed civil matters or contractual, whereas others may be vexatious in

nature. Complaints often have multiple issues, some of which resolve in the favour of complainants and some that do not. It is rare that complaints are resolved in their entirely in the favour of one or other of the parties.

b. There is no simple way of averaging out the time to resolve a complaint that gives a meaningful representation. Comparisons between jobs are difficult to make. For example, a multi-unit job will inevitably be more complicated than single residential.

SIMON CORBELL: The answer to the Member's question is as follows:—

- 1. The Government has developed a Sustainable Transport Network (STN) with the identification of rapid transport corridors together with a supportive local network structure. The Government developed this network through community consultations undertaken during 2009. (refer http://www.tams.act.gov.au/ data/assets/pdf file/0010/157996/ACT Strategic PTNP
 - http://www.tams.act.gov.au/ data/assets/pdf_file/0010/157996/ACT_Strategic_PTNP_E XEC_SUMM.pdf)
 - This STN forms the basis for the Transport for Canberra policy development which is integrated with the planning and climate change strategies being developed concurrently in Environment and Sustainable Development (ESD).
- 2. The STN proposes **Rapid Transit Corridors** that connect Belconnen City Woden Tuggeranong and Gungahlin City Russell Barton Kingston Fyshwick. It also proposes to connect Gungahlin Belconnen Molonglo Woden through an orbital

- corridor in the medium to long term. The STN will establish permanent transit corridors with rapid travel with 15 minute or better frequency. To support these rapid corridors, the STN proposes another layer of local frequent network that provides relationship to rapid corridors and land use planning.
- 3. The aim of the Master Plan program for Group Centres and along transport corridors is to provide a public participation mechanism in the process of elaborating on where and how urban intensification will occur and create more diverse urban environments. This can allow more people to live close to work and again help to make better use of established infrastructure.

Master Planning for the rural villages is aimed at retaining the character of these villages while improving their viability and vibrancy.

- a. The government has given priority to a number of group centres across Canberra;
- b. The selection criteria include economic vitality, provision of social infrastructure, condition of the public spaces and assets. Further consultation with community on the program is envisaged as part of preparing a draft planning strategy;
- c. The proposed Change of Use charge is not expected to impact on the master planning program. The master plans are prepared to guide change and development arising from growth; and
- d. As stated above these plans are prepared to mange change and guide development. The Change of Use charge will ensure the government can realise opportunities to invest in pubic assets, where they are most needed, as development occurs.
 - The government can fund and improve social infrastructure, schools, medical centres or community halls rather than be tied to improving civil infrastructure which occurs with developer contributions made through offsite works.
