In relation to: Urban Lakes

1. Of the 121 urban lakes and ponds can you, please provide a list of when each of them was cleaned and how long it took to clean them?

**Chris Steel MLA: The answer to the Member’s question is as follows:–**

1. There was no allocation of initiative funding provided for lakes cleaning in 2017-18, so cleaning of lakes was done on an ad-hoc basis. As a consequence, no formal records of lake cleaning operations were kept for the financial year 2017-18. The lake cleaning records from 1 July 2018 to 9 October 2018 are not available. The following table provides a summary of all lake cleaning work carried out from 10 October 2018 to 22 November 2018.
