Asked by MS CASTLEY:

In relation to: Electric Vehicle Charging Stations

MS CASTLEY: I have a supplementary. How long have you got for the market sounding of the — how long is this three phase approach going to take.

Mr McGlynn: Yes, I do not think we have nailed down the exact timing, but I mean, we would think that the market sounding would take, you know, a few weeks to a month just to sort of get through that process and evaluate that, but -

MS CASTLEY: Did you say you are bringing consultants in for that?

Mr McGlynn: I do not think we are bringing consultants in for that. That is something that we can just do and go and talk to the industry about.

MS CASTLEY: So that is — you know that there will — you know the cost within your department? Can you tell me what that will be, to go through these three phases, the master plan, the market sounding-

Mr McGlynn: I have not got the cost in front of me. I can go and find that on notice if we need to.

MS CASTLEY: Yes.

Mr McGlynn: But that market sounding — we have funding that came out of the budget to — for staffing to take us through that process, that necessary funding.

MINISTER RATTENBURY: The answer to the Member's question is as follows:-

Through the 2020-21 ACT Budget, the Government committed \$2.664 million over four years to support charging infrastructure and Zero Emissions Vehicle (ZEV) industry development.

Of this amount, \$1.1 million has been allocated to staff costs: one Senior Officer Grade C and two Administrative Service Officers (Class 6).

These staff will:

conduct the market sounding process;

- design and implement the charging masterplan; and
- design and implement the process for establishing the 50 public chargers.
