Mr Miners: I have two more things to add very quickly. One of the key things about the strategy is that it does focus on mental health in terms of everyone. It does not just look at one part of the spectrum; it looks at mental health right across the spectrum in terms of the five in five, rather than the one in five who will suffer severe mental health problems.

It is about making sure that it is something that everyone is aware of and reducing that stigma, as Michael said, so that these issues are talked about. Those things can be very hard to measure. In a lot of ways, it is what does not show up that is what we are really looking to measure. It really is about making sure that people can address the mental health issues, that people are aware of it, and that we can deal with the issues before they actually become issues and make sure everyone has a very positive, supportive workplace to work in.

In relation to: Workplace visits

Ms Agius: So in 2019 there were 1,629 workplace visits. Is that the figure you are referring to?

THE CHAIR: Yes.

MR CAIN: I had. Thank you.

Ms Agius: Thank you. Sorry, just to confirm. So what you are referring to there is the improvement notices, prohibition notices and infringement notices. Some of those may be repeat notices. So they may not be in relation to the same workplace. So they will not necessarily mean that they are separate notices that have been issued at every one of those sites. It could be one site that has 10 notices for instance.

MR CAIN: Is there a way that that can be made clearer? Perhaps I will do a QON on that but—

Ms Agius: I am happy to take that on notice. Part of the issue is that we have started to collate some really good data now at WorkSafe ACT because we have implemented some new ICT systems and whilst I can say going forward we can absolutely do that, but I would need to check whether or not that is available to us.

RACHEL STEPHEN SMITH MLA: The answer to the Member's question is as follows:-

The case management system relied upon by the Office of the Work Health and Safety Commissioner (WorkSafe ACT) during 2019-2020 does not allow for any further breakdown of the data, particularly the issuing of multiple notices on a single Person Conducting a Business or Undertaking (PCBU).

WorkSafe ACT has implemented a new case management system which allows for greater clarity in the data it collects and reports – particularly in regard to workplace visits and notices issued as a result. From 2020-2021 onward WorkSafe ACT will report in detail on its compliance activities in line with its *Compliance and Enforcement Policy*, particularly the issuing of notices and the use of other enforcement tools.

In relation to: Workplace inspections repeat notices and repeat infringements

THE CHAIR: When we started off, Mr Cain asked you about the 1,629 workplace inspections and you said that some of them maybe repeat notices and repeat infringements?

Ms Agius: In the same workplace. So there could be one worksite that might, for instance, have improvement prohibition infringements. So whilst the figures, if you added them all up looks like we have only got a 24 per cent of compliance, it is actually one workplace might have 10 or 20 of those notices.

In relation to repeat employers one of the things that we have found in the residential construction strategy operation safe prospect is we are not seeing a lot of repeat non-compliance. So when we are revisiting sites generally if we have been to a site before that site will now be compliant so that when we are out there issuing, you know, we issued 77 last week.

I think none of those—but I am happy to confirm that and take it on notice—I don't think any of those were repeat offenders; if I can use that term.

RACHEL STEPHEN SMITH MLA: The answer to the Member's question is as follows:-

The recent Operation Safe Prospect audit of Denman Prospect conducted on 17 February 2021 detected 14 non-compliant PCBUs out of 26 construction sites inspected. The 14 PCBUs had previously been subjected to regulatory sanctions by WorkSafe ACT. The 14 PCBUs (builders) were subsequently issued further notices for the non-compliances detected by WorkSafe ACT inspectors.

In relation to: Portable Long Service Leave Legislation

MR CAIN: What review rights exist for someone who receives a negative decision—their request is for the exemption and that is denied?

Mr Gentleman: They would have to join the scheme.

Mr Young: There would be none.

MR CAIN: There are no review rights?

Mr Young: It is up to ministerial discretion.

MR CAIN: What about under the Administrative Decisions (Juridical Review) Act?

Mr Young: I do not believe that would apply.

MR CAIN: It is something I will be doing a QON on, but the AD(JR) Act does provide a right to review a government decision, absent a specified review path within the legislation itself. That is my understanding, but I will get some clarity from you on that.

Mr Gentleman: I will take that on notice.

RACHEL STEPHEN-SMITH MLA: The answer to the Member's question is as follows:-

Section 13 of the Long Service Leave (Portable Schemes) Act 2009 (Portable Schemes Act) allows the Minister to make a statutory instrument declaring the Portable Schemes Act to not apply to a person (or persons), work or activity, limiting the coverage of that Act as currently in force. Such declarations, if made, receive the scrutiny of the Assembly as a disallowable instrument.
