Ref: Output 2.1, Budget Outlook, Table 3.6.8: Total Commonwealth funding to the ACT, line item “local roads and community infrastructure”, p174.

In relation to: Lake Ginninderra Swimming Area Refresh

1. Regarding the 2020 election promise to fund the refresh of the Lake Ginninderra swimming area, is there funding for this in the budget?
  - a. If so, under what line item is this funding included?
    - i. How much funding will there be for the refresh?
    - ii. When will the refresh begin the design phase and construction phase?
    - iii. When will the refresh be complete?
    - iv. Will there be a public consultation phase?
    - v. Are there any specific plans for the refresh already? If so, what are those upgrades?
    - vi. In what area of the Lake will the refresh occur?
  - b. If not, why has the Government not funded this commitment?

**Chris Steel MLA: The answer to the Member’s question is as follows:–**

1. Yes.
  - a. Funding has been allocated through the TCCS expense line item of \$2.730m for road and community infrastructure on page 102 of the 20-21 Budget Outlook.
    - i. \$0.3m.
    - ii. July 2021.
    - iii. December 2021.
    - iv. Targeted consultation will be undertaken.
    - v. The LRCl grant agreement refers to revitalisation of Western Foreshore park including topping up beach sand, landscaping improvements and an outdoor shower facility.
    - vi. Western Foreshore park.
