- b) If there were any contracts within this period that were suspended? If so, please provide:
 - i) The contract number
 - ii) The date that the contract was suspended
 - iii) The reasons for the contract suspension
 - iv) The amounts (if any) that were paid under the contract whilst suspended
 - v) Whether the contract was recommenced and, if so, when?
 - vi) All documentation relating to the suspension.
- c) If there were any tenders within this period that were cancelled? If so, please provide:
 - i) The tender number
 - ii) The date the tender was cancelled
 - iii) The reasons for the tender cancellation
 - iv) All documentation relating to the cancellation.
- d) If there were any tenders within this period that were suspended? If so, please provide:
 - i) The tender number
 - ii) The date the tender was suspended
 - iii) The reasons for the tender suspension
 - iv) Whether the tender was recommenced and, if so, when?
 - v) All documentation relating to the suspension.

CIT, an independent body with a governing board, advises that according to records, the following contracts were terminated by mutual agreement:
