- 945 **MS LEE**: To ask the Minister for Transport and City Services How many (a) graffiti incidents have been reported through the Fix My Street website, (b) days on average did it take for graffiti to be removed once it was reported and (c) infringements have been issued in relation to graffiti by ACT Policing, for the financial years 2017-2018 to 2021-2022 (inclusive).
- 946 MR CAIN: To ask the Minister for Transport and City Services
 - (1) Can the Minister provide a breakdown of cost elements for the delivery of play spaces in the ACT, in relation to the categories of (a) district, (b) central and (c) local, play spaces.
 - (2) What is the geographic breakdown by suburb of play spaces across the ACT.

 - (5) What is expected to be the total bus capacity of the Woden bus depot.
 - (6) How many of these buses will be zero emissions
 - (7) Will the depot be built so that the entire fleet based at Woden can be zero emissions.
 - (8) How many new buses will be acquired for the Woden depot in addition to regular fleet replacement at the existing depots.

- 951 **MS CLAY**: To ask the Minister for Transport and City Services
 - (1) How is the multimodal network plan going to be integrated into existing documents within Transport Canberra and City Services Directorate, including planning policies, planning guides, frameworks, strategies, design guides, design standards and practitioner tools.
 - (2) What new or updated information is the plan expected to provide.
 - (3) How will this differ from existing documents within the directorate.

 - (3) How many zero-emissions buses can currently operate from the (a) Belconnen and (b) Tuggeranong Bus depots.
