Good Morning Janine

Yesterday afternoon I took an electronically recorded voluntary statement from [P01 P01], the chief complainant in the Papilio Barton matter.

During this meeting, she made the following disclosures:

- Around the end of July 2023, a parent by the name of [P01 P01] complained to [P01 P01] (who was then the educational leader in the toddlers room at Papilio Barton) about the conduct of a male educator named "[P01 P01]".
- [P01 P01] raised the issue with the then NS, [P01 P01]. [P01 P01] also spoke with [P01 P01].
- The child's name was [P01 P01] (toddler).
- The Parent disclosed to [P01 P01] that she did not want [P01 P01] around [P01 P01] because he had kissed her and picked her up. She also made a request that [P01 P01] not change [P01 P01]'s nappy.
- These disclosures are recorded as part of the complainant's statement for my current investigation.

I have had a look in G: and there is nothing from Papilio from July 2023 regarding the notification of a complaint of this nature.

Could you please advise me of how I should deal with this. Do I create a new notification?
