P01P01 made verbal allegation to **P01P01** (Approved Provider and teacher) on 5/3/21 that **P01 P01** had hurt his hand.

P01 is currently on one week sick leave due to injury sustained at work 5/3/21

Actions taken by provider:

- **P01** parent, **P01 P01** was notified by phone before 12pm to make her aware of **P01**'s behaviour incident where he had injured another child and then whilst being redirected by an educator **P01** he has head butted her in the head and face causing injury. **P01** then informed her on collection at 12.17pm of **P01** saying that **P01** had hurt his hand
- statements from Director and **P01P01** collected on 5/3/21
- Camera footage viewed and description attached within Director statement
- interviews and statements from other educators in Preschool room to be collected 10/3/21 when they return to work and will be sent to CECA
- review of child centre profile and appropriate safe practices for managing escalated behaviours of children
- interview with **P01** on her return from sick leave after 15/3/21
- meeting held with **P01 P01**, regarding **P01**'s behaviour support strategies, child centre profile and other information.
