- *1 **MR PETTERSSON:** To move—That this Assembly:
- (1) notes that:
 - (a) over two million Australians are employed casually, representing around one in five Australian workers;
 - (b) people working in casualised work are some of the most economically vulnerable in our community;
 - (c) certain occupations and industries are highly insecure and workers in these industries do not usually have access to sick and carer's pay;
 - (d) sick and carer's pay provides financial security and protects workers wellbeing when they are unable to attend work;
 - (e) the COVID-19 pandemic has highlighted the dangers to workers and our workplaces when insecure workers feel compelled, for financial reasons, to attend work whilst sick; and
 - (f) the Victorian Government has recently announced it will introduce the Victorian Sick Pay Guarantee to provide up to five paid sick days for casual workers per year;
 - (2) acknowledges the work of the ACT Government to:
 - (a) better protect workers by legislating a labour hire licensing scheme that has promoted responsible practices in the labour hire services industry;
 - (b) utilise its purchasing power to improve standards in certain industries through the Secure Local Jobs Code;
 - (c) implement and expand the portable long service leave scheme to ensure that workers in transient industries are able to access this workplace entitlement;

- (d) protect workers who lost their job in the COVID-19 pandemic with the Jobs for Canberrans initiative; and
- (e) establish the Secure Employment Framework to support the transition from insecure work arrangements to permanency within the ACT public sector; and
- (3) calls on the ACT Government to to:
 - (a) continue to materially improve the working conditions of ACT residents; and
 - (b) investigate providing sick and carer's pay for casual and contract workers who work in industries that do not usually have access to sick and carer's pay. This investigative work should be undertaken in consultation with relevant trade unions and other stakeholders.

***2 MS LEE:** To move—That this Assembly:

- (1) notes:
 - (a) the announcement made by the Labor Senator for the ACT, Katy Gallagher, to cut \$3 billion from Australian Public Service contractor and consultant jobs if Labor is elected;
 - (b) the majority of these jobs are in Canberra;
 - (c) these Canberra jobs have been called “wasteful spending” by the Australian Labor Party;
 - (d) they will be replaced by only \$500 million in front line jobs, mostly outside Canberra; and
 - (e) this would equate to the loss of thousands of highly skilled jobs in Canberra, and billions of dollars cut from the ACT economy;
- (2) writes to the Leader of the Australian Labor Party defending Canberra jobs in the public and private sectors;
- (3) calls on the Federal Opposition to drop the policy of massive job cuts in Canberra; and
- (4) condemns ACT Labor Senator Katy Gallagher for proposing a \$3 billion hit to Canberra jobs, and the ACT economy. (*Notice given 2 May 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A*).

***3 MR HANSON:** To move—That this Assembly:

- (1) notes:
 - (a) the importance of defence industry to the Canberra economy and local jobs;
 - (b) the importance of the defence industry to the security of Australia; and
 - (c) the important role of western military equipment, including Australian equipment, in the defence of the Ukrainian people;

- (2) further notes:
 - (a) the recent attack on the defence industry by the Greens in this Assembly;
 - (b) the attack on the defence supplier that is providing vital support to Ukraine; and
 - (c) that the defence supplier in question has its Australian headquarters in Canberra;
- (3) affirm its support for Canberra's defence industry sector; and
- (4) support the Australian Federal Government and others in their provision of equipment to enable Ukraine to defend their people. (*Notice given 2 May 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A*).

*4 **MS CLAY:** To move—That this Assembly:

- (1) notes that:
 - (a) 62 percent of the ACT's tracked climate emissions come from transport, primarily cars. Cars also contribute to congestion and poor air quality;
 - (b) not enough people in Canberra currently use public transport. Only 4.6 percent of all journeys were taken by bus according to the ACT and Queanbeyan-Palerang Household Travel Survey 2017;
 - (c) service frequency and reliability, particularly on weekends, are barriers to bus use for some Canberrans; and
 - (d) Transport Canberra has fewer woman bus drivers than the national average (around 11 percent in the ACT compared to 13 percent nationally);
- (2) further notes that:
 - (a) Transport Canberra is operating an interim timetable due to COVID-related staff absences;
 - (b) weekend services are only available two hourly for most services after 12 pm on a Saturday and all day Sunday;
 - (c) Victoria has a detailed Women in Transport program and strategy which includes a target of 10 percent increase every year in women drivers;
 - (d) Transport Canberra's enterprise agreement does not support workplace flexibility. It reflects historic work patterns of Monday to Friday work for full-time permanent bus drivers. A full-time bus driver who wants to work on weekends must either become a casual employee or increase their working week to six or more days. This does not provide modern workforce flexibility, does not match government commitments to flexible working arrangements, does not allow parents and carers to make permanent care arrangements around work and does not support hourly weekend services or weekend reliability; and

- (e) around Australia, other public transport operators and service sector employers provide a range of alternative working structures which enable flexible working hours, such as:
 - (i) a work roster that includes permanent part-time positions involving fewer than five working days such as Tuesday to Thursday; and
 - (ii) a permanent position that involves a five day work week, or a short work week, which may include weekend days as part of the standard roster, such as Tuesday to Saturday (five days) or Sunday to Wednesday (four days); and
- (3) calls on the ACT Government to:
 - (a) expand Transport Canberra’s workforce to provide enough drivers to return to the regular timetable as soon as possible this year;
 - (b) pursue an outcome through the current enterprise bargaining processes which can achieve the Government’s previous commitment for hourly route bus services all weekend, from 2023;
 - (c) develop a Women in Transport Program and target to increase the percentage of women across Transport Canberra in driver roles;
 - (d) work with the Transport Worker’s Union as an employee representative, and Transport Canberra staff directly, to give new and existing drivers the option to work full or part-time without having to work a Monday to Friday work week; and
 - (e) update the Assembly by the first sitting day in 2023 on this motion. *(Notice given 2 May 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A).*

- *5 **MS LEE:** To move—That this Assembly:

- (1) notes:
 - (a) in 2014, a review of the National Capital Plan was undertaken to better balance land use options for the ACT;
 - (b) in 2016, the National Capital Plan was amended, greatly reducing the amount of ACT land controlled by the Commonwealth and transferring it to the jurisdiction of the ACT Government;
 - (c) as part of the amended National Capital Plan, the National Capital Authority identified 726 hectares of land in Tuggeranong, west of the Murrumbidgee, as suitable for potential residential development;

- (d) the ACT Labor-Greens Government has the jurisdictional authority to release this additional land in West Tuggeranong for residential purposes;
- (2) further notes:
 - (a) there is a housing crisis in Canberra, driven in part by the decisions of the ACT Labor-Greens Government;
 - (b) 12,417 Canberrans applied for 101 blocks of land in Whitlam in March 2022;
 - (c) 8,700 Canberrans applied for 71 blocks of land in Macnamara in February 2022;
 - (d) 7,484 Canberrans applied for 115 blocks of land in Taylor in October 2021;
 - (e) 7,566 Canberrans applied for 92 blocks of land in Whitlam in March 2021;
 - (f) there is clear demand for blocks of land for detached housing, and the Labor-Greens Government's land release strategy does not meet the community's needs or wants;
 - (g) more must be done to increase the supply of detached housing in Canberra; and
 - (h) medium and high density housing, such as townhouses and apartments, form part of a balanced approach to provide more choice; and
- (3) calls on the ACT Government to:
 - (a) provide Canberrans with more choice, including land for detached and medium-density housing in the Indicative Land Release Program;
 - (b) give proper consideration to possible future suburban sites now permitted by the National Capital Plan;
 - (c) commit to a feasibility study into the West Tuggeranong site and its potential for residential development and in doing so, take into consideration:
 - (i) housing affordability for thousands of Canberrans who want the option to purchase land for a detached house;
 - (ii) identification and assessment of environmental impacts, including minimisation, mitigation and offsets; and
 - (iii) the future infrastructure needs of any potential new residential development to deliver essential services; and
 - (d) report back to the Assembly by the last sitting day in 2022. (*Notice given 2 May 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A*).

ASSEMBLY BUSINESS

Notices

- *1 **MS CASTLEY:** To move—That this Assembly:
- (1) notes:
 - (a) on 5 April, the Australian Nursing and Midwifery Association (ANMF) launched a public campaign calling on the ACT Government to conduct an urgent inquiry into the operation of the Dhulwa Secure Mental Health Unit;
 - (b) the union said nurses had reported more than 100 physical assaults by patients over a six-month period to February this year with one nurse likening working at Dhulwa to being “sent into the killing fields”;
 - (c) nurses say they have pleaded with the Government to keep them safe and the government has “failed” them over safety;
 - (d) staff turnover is high and nurses fear the Government’s failure to respond to their serious concerns poses “an imminent risk of a catastrophic event”; and

- (e) violence has been an issue at Dhulwa since it opened. In 2018, several nurses reported being punched in the face and kicked in the head during multiple assaults by a patient and ACT Policing investigated;
- (2) further notes that Minister Davidson:
 - (a) has been slow to respond to the nurses' pleas for an inquiry and dragged her feet on the issue;
 - (b) told Question Time on 6 April she was "listening" to nurses and made a flippant remark, "He's got my number. Call me, Maybe?" referring to the ANMF branch secretary; and
 - (c) announced on 2 May the Government would conduct an independent inquiry into legislative, clinical and governance policies at Dhulwa; and
- (3) refers to the Standing Committee on Health and Community Wellbeing the following matters:
 - (a) the adequacy of current security and staff safety arrangements to protect nurses at Dhulwa;
 - (b) staff numbers and roles/positions to ensure staff are safe and protected at work; and
 - (c) current protocols and procedures for staff responding to, and reporting on, incidents and violence. (*Notice given 2 May 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A*).

*2 **MR DAVIS:** To move—That this Assembly:

- (1) notes that:
 - (a) the ACT is experiencing a shortage of long-term rental accommodation which is increasing rent;
 - (b) platform-based short-term accommodation is an increasingly common way for landlords to earn an income on their properties without entering into tenancy agreements;
 - (c) an entire residential dwelling which is used for platform-based short-term accommodation, is a habitable dwelling that is removed from the rental market;
 - (d) bringing platform-based short-term accommodation back into the long-term rental accommodation market would create an immediate increase in housing supply without urban sprawl and carbon emissions from construction;
 - (e) there are currently no regulations or restrictions on platform-based short-term accommodation in the ACT;
 - (f) many cities around the world, and within Australia, have implemented regulations on platform-based short-term accommodation with the aim of increasing rental affordability; and

- (g) several Australian state parliaments have undertaken inquiries and tabled legislation to address this issue including South Australia, Tasmania, Western Australia, New South Wales, and Victoria;
- (2) further notes that:
 - (a) the local hotel industry has been disproportionately impacted by the economic impacts of COVID-19; and
 - (b) over the last 10 years, platform-based short-term accommodation providers have competed with the local hotel industry creating excess capacity within licensed hotels;
- (3) requests that the Standing Committee on Planning, Transport and City Services consider investigating the impact of platform-based short-term accommodation providers on rental affordability in the ACT;
- (4) requests the Committee, should it decide to inquire into this matter, to investigate:
 - (a) the current regulatory and planning settings for managing platform-based short-term accommodation in other states in Australia;
 - (b) the current regulatory and planning settings for managing platform-based short-term accommodation in the ACT;
 - (c) whether these settings may contribute to the number of long-term rental properties available in the ACT;
 - (d) whether additional regulatory and planning settings are required to manage the ACT's platform-based short-term accommodation industry; and
 - (e) any other related matters; and
- (5) requests the Committee, should it decide to inquire into this matter, determine a reporting date based on the Committee's capacity. (*Notice given 2 May 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A).*
