- (2) How many complaints have there been of bullying and harassment for each division in ACT Health for the 2020-21 and 2021-22 financial years?
- (3) Has there been any compensation provided to complainants of bullying and harassment in CHS and ACT Health? If so provide a breakdown by (a) CHS and (b) ACT Health of how much for each division during (i) 2020-21 and (ii) 2021-22.
- (4) How many staff that submitted a complaint due to bullying and harassment have left (a) CHS and (b) ACT Health since 2020 to present?
