Standing Committee on Public Accounts - Report No 14 Inquiry into Auditor General's Performance Report January 2022- June 2022

Government Response

Introduction

At its meeting of 30 June 2022, the Legislative Assembly Standing Committee on Public Accounts (the Committee) resolved to inquire into the following Auditor-General performance audit reports:

- a) 1/2022 Management of detainee mental health services in the Alexander Maconochie Centre (AMC)
- b) 2/2022 Fraud Prevention
- c) 3/2022 Taxi Subsidy Scheme
- d) 4/2022 Governance arrangements for the planning of services for Parkwood, Ginninderry

The Committee held a public hearing on 8 December 2022 and circulated their report out of session on 2 March 2023.

Across the four performance audit reports being inquired into, 12 recommendations were made to the Government. Responses to these recommendations are provided below.

Recommendation 1 The Committee recommends that the ACT Government meet the mental health needs of all detainees.	Agreed This recommendation will be met by implementation of the 19 recommendations as outlined in the government response to the <u>Auditor-General's Report No 1/2022</u> which was tabled in the ACT Legislative Assembly on 2 August 2022. The report outlined a total of 19 recommendations with 10 agreed to, 8 agreed in principle and 1 recommendation noted. A full copy of the government response can be found <u>here</u> .
Recommendation 2 The Committee recommends that the ACT Government conduct a feasibility study on expanding the Hume Medical Centre.	Noted Examination of the need to expand the Hume Health Centre, or other ways to deliver improved health services, will be undertaken as part of broader infrastructure planning for the Alexander Maconochie Centre (AMC) precinct. A range of physical works to refurbish and expand the capacity of the Hume Health Centre was completed in 2022.
Recommendation 3 The Committee recommends that the ACT Government provide structured days for detainees that cater to their mental health and wellbeing; such structured days should include access to improved alcohol and other drug rehabilitation programs and education programs, designed to assist detainees' mental health and wellbeing.	Noted A structured day that supports mental health and wellbeing includes activities and recreation time. ACT Corrective Services (ACTCS) provides alcohol and drug rehabilitation programs, education programs and recreation activities. These are reviewed on a regular basis to determine effectiveness and updated as needed. ACTCS and the Canberra Health Services' Forensic Mental Health Service are in the process of implementing programs and therapeutic support reforms that will positively impact practices at the AMC. ACTCS has increased education and activities across the Centre. Activities officers now offer programs for 10 hours a day, seven days a week. A new Programs and Services Review Committee has been established to ensure programs and services are meeting the needs of detainees and can be supported by the AMC. This will improve the coordination of programs and services across the AMC.

Recommendation 4 The Committee recommends that the ACT Government agree to all of the recommendations of the <u>Auditor-General's</u> <u>Report No 1/2022.</u>	Noted The government response to the <u>Auditor-General's Report No 1/2022</u> was tabled in the ACT Legislative Assembly on 2 August 2022. The report outlined a total of 19 recommendations with 10 agreed to, 8 agreed in principle and 1 recommendation noted. A full copy of the government response can be found <u>here</u> .
Recommendation 5 The Committee recommends that the ACT Government continue with its planned update of the conflict-of-interest policy.	Agreed The ACT Government agrees with the Auditor-General's recommendation. The Conflict-of- Interest Policy was updated in June 2021 by CMTEDD, and is next due for review in June 2023. The current policy is available <u>here.</u>
Recommendation 6 The Committee recommends that the ACT Government adopt the recommendations of the Auditor-General's Report No 2/2022.	Noted As per the legislation, the government response to the <u>Auditor-General's Report No 2/2022</u> was provided to the Speaker for presentation out of session on 3 July 2022, and tabled in the legislative assembly on the first available sitting day being 2 August 2022. The report outlined a total of 6 recommendations with 4 agreed to and 2 agreed in principle. A full copy of the response can be found <u>here</u> . The ACT Government is committed to strengthening fraud prevention measures and fostering fraud awareness across the ACT Public Sector.
Recommendation 7 The Committee recommends that the ACT Government revise the caps in the taxi subsidy scheme in line with the results of the disability strategy consultation.	Agreed in-principle In line with the Government's response to the Auditor General's report, any future change to the Scheme will take the Disability Strategy consultation into consideration. These decisions would be subject to future Budget decisions.

RECOMMENDATION	GOVERNMENT RESPONSE
Recommendation 8 The Committee recommends that the ACT Government address geo-spatial disadvantage of users in the taxi subsidy scheme.	Agreed in-principle The Government considers the scheme should be effective regardless of where users live. For simplicity of implementation, the scheme provides the same level of concession across all residential locations in the ACT based on the travel needs of all users. In general, we consider the scheme is successful in this regard. However, the Government is aware, through the ACT Disability Strategy consultation, that there are difficulties for some users accessing specific medical experts when they live in relatively distant parts of Canberra. As outlined in the Government's response to the Auditor General's report, future policy changes will take into account this feedback from the Disability Strategy consultation regarding the expenses of members who live a significant distance from essential services. This could be partially addressed through the subsidy cap (see response to Recommendation 7).
	The Taxi Subsidy Scheme is an important component of creating and maintaining an accessible community. Like any scheme, it will have limits. The needs of scheme users should be analysed in the context of the full range of support the Government provides in creating an accessible community.
